This 'Cover Letter' serves two purposes and is in Reference to: **BPED20060606AGM**.

Purpose 1 Introduction of FCC Form 302FM, Application For Station License, for Radio Station WPSR (FM).

Purpose 2 Request for "Program Test Authority".

WPSR (FM) herein is filing the required FCC 302FM, Application For Station License.

The WPSR (FM) "Construction Permit" has a "Restriction" that required WPSR to perform RFR Safety Measurements under "Equipment Test Authority". The RFR Safety Measurements have been performed and are documented within this FCC 302FM, Application For Station License.

The RF Measurements prove that the New 8 Bay, 1/2 Wavelength Bay Spaced Antenna meets all RFR Safety Requirements.

The "Restriction" on the WPSR (FM) "Construction Permit" requires WPSR to "REQUEST" "Program Test Authority", when filing this FCC 302FM, Application For Station License.

Accordingly, WPSR herein "Requests" the FCC to "Authorize" "Program Test Authority" for WPSR (FM).


WPSR (FM), now having completed the "Equipment Testing" period (*Performing the required RFR Safety Measurements*), is presently "Off The Air", as required by the

WPSR (FM) anxiously awaits the FCC’s “Grant” of “Program Test Authority”, while we await the issue of a new license to cover WPSR (FM)’s operation with the “New FM Antenna”.
