

EXHIBIT 5
DESCRIPTION OF TRANSACTION

This application (“Application”) is one of several related FCC Form 314 applications being filed simultaneously and seeks the consent of the Federal Communications Commission (“FCC” or “Commission”) to the assignment of certain broadcast licenses as part of that certain Asset Purchase and Exchange Agreement (“APEA”), dated as of April 28, 2012, by and among Cumulus Broadcasting LLC, Cumulus Licensing LLC, Citadel Broadcasting Company, and Radio License Holding CBC, LLC (collectively, “Cumulus”), on the one hand, and Townsquare Radio, LLC, Townsquare Media of Bloomington, Inc., Townsquare Media of Peoria, Inc., and Townsquare Media Licensee of Peoria, Inc. (collectively, “Townsquare”), on the other hand.¹ The APEA provides for Townsquare to acquire fifty-five (55) radio stations in eleven (11) markets and for Cumulus to acquire ten (10) stations in two (2) markets.²

In accordance with the APEA, the following applications seeking Commission consent to the assignment of each of the licenses specified below from Townsquare to Cumulus are being filed concurrently herewith:
