

### **Changes in Interests**

Legal control of Vassar College resides with the Board of Trustees. The instant application is being filed to notify the Federal Communications Commission of the gradual change in the membership of the Board of Trustees of Vassar College and to obtain FCC consent for the current membership. Licensees may be required to request Commission approval if membership of the controlling body of the licensee is changed by more than 50%, even if that change is incremental. This application is being filed to report the gradual change in control.

Below is a chart summarizing the change in the board between 2006 and the present, then a list of the old members of the Board of Trustees for Vassar College, followed by the new members of the Board of Trustees for Vassar College.
