Dear Counsel:

This is in reference to the request filed September 16, 2009, on behalf of Access.1 New Jersey License Company, LLC ("ANJ"). ANJ requests extension of the special temporary authority ("STA") granted on April 7, 2009, to operate Station WGYM<sup>1</sup> with reduced power.

In support of the request, ANJ states that it has been attempting to repair its daytime transmitter, and has returned the transmitter to service with greatly reduced power. ANJ further states that its repair efforts have been difficult because the only road leading to the transmitter site is blocked.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Our review indicates that the licensee has made progress toward restoration of licensed operation, but additional time is required for completing the work. Thus, extension of STA is

warranted.

Accordingly, the request for extension of STA IS HEREBY GRANTED. Station WGYM may continue to operate during daytime hours with reduced power. It will be necessary to further reduce power or cease operation if complaints of interference are received. ANJ must notify the Commission when licensed operation is restored.<sup>2</sup> ANJ must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **March 24, 2010**.
