

**ENGINEERING STATEMENT
RADIO MULTIPLE OWNERSHIP ANALYSIS**

This radio multiple ownership analysis was prepared on behalf of NRC Broadcasting Mountain Group, LLC to consider the common ownership of stations KFMU-FM, KIDN-FM, KKCH(FM), KNFO(FM), KTRJ(FM), KSMT(FM), KSPN-FM, and KTUN(FM), as well as any other stations in which NRC Broadcasting Mountain Group, LLC or its principals hold an attributable interest. The analysis was done under the FCC “Interim” contour method, as the stations are located outside of any Arbitron market.* Below is a tabulation of facilities for each station considered.

The principal community contours of these stations are depicted on a map included herein as Figure 1. Since the principal community contours (5 mV/m for AM stations, 3.16 mV/m for FM stations) of the 8 stations to be commonly owned are in some way involved in overlap with some of the stations tabulated above, an ownership study was prepared in accordance with the Federal Communications Commission multiple ownership rules as outlined in Section 73.3555.

Radio Markets

The “radio markets” applicable to common ownership of the subject stations are defined as the areas encompassed by the mutually overlapping principal community contours of the stations proposed to be commonly owned. There are sixteen “radio markets” to be considered. The table below lists the defined markets:

Count of Stations in Defined Markets


The number of radio stations in a “radio market” is determined by counting the operating stations having principal community contours which overlap or intersect the principal community contours which define the radio market. Only those stations located within 92 km of the perimeter of the mutual overlap area of the defined market area were employed in the count of stations. The results of the analysis are tabulated below:

Sheets 1 thru 16 of Figure 2 are tabulations of the radio stations identified in the defined radio markets. Only known licensed, operating stations were employed for the study. Distances to the AM coverage contours were predicted using the antenna patterns as identified in the Commission's AM database and the appropriate Ground Wave Field Strength versus Distance Graph of 47 CFR 73.184. Ground conductivity data were obtained from FCC Figure M3. Distances to the FM contours were determined based on the method of 47 CFR 73.313. Terrain data was derived from the N.G.D.C. 30 second computer database for each of the FM stations using radials evenly-spaced every 1 degree of azimuth.



