**Re: Request for Extension of Special Temporary Authority for
Phased Transition Relief (FCC File No. BDSTA-20080818ACJ)
KZTV-DT, Corpus Christi, Texas**

Dear Sir or Madam:

Eagle Creek Broadcasting of Corpus Christi, LLC ("*Eagle Creek*"), licensee of Station KZTV(TV), Corpus Christi, Texas (Facility ID No. 33079) (the "*Station*"), by its attorneys, hereby requests an extension of its Special Temporary Authority ("*STA*") for phased transition relief (FCC File No. BDSTA-20080818ACJ) to permit KZTV to continue to operate on its pre-transition DTV Channel 18 and extend its post-transition construction deadline for the full time contemplated by the Commission, until February 18, 2010.¹

KZTV is a CBS Network affiliate that currently operates on its pre-transition Channel 18. On March 24, 2008, Eagle Creek filed a construction permit application on behalf of KZTV for post-transition operation on Channel 10.² As Mexican concurrence to the station's post-transition authorization had not been obtained, Eagle Creek filed a request for phased transition STA to permit the station to continue temporary operation on its pre-transition digital channel beyond the digital transition date on August 18, 2008. Although Mexican concurrence was ultimately obtained after nearly nine months, the station's digital transition plan was seriously complicated by this delay.

In addition, on July 30, 2008, Eagle Creek had filed an application requesting the Commission's consent to the assignment of the license for KZTV to SagamoreHill of Corpus Christi Licenses, LLC.³ That application is the subject of a petition to deny filed by an in-market

competitor and remains pending after more than one year. The pendency of this assignment application has further complicated the Station's digital transition plan. Given the significant expense of a new Channel 10 digital transmitter, and Eagle Creek's understanding that the proposed assignee plans to utilize a different, and even more expensive, digital transmitter, the Station has not yet been able to finalize its digital transition plan and order the necessary equipment.

Eagle Creek emphasizes that it has been working diligently and expeditiously to resolve these issues, including regular contact with the proposed assignee. Indeed, Eagle Creek anticipates ordering its final digital transition equipment in the next few days. However, given the time necessary for delivery and installation of the Station's Channel 10 digital transmitter, an extension of the Station's existing STA is necessary.

Under the Commission's rules, a station is permitted to temporarily remain on its pre-transition channel while it completes construction of its final digital facilities beyond the analog cutoff date if: (i) it serves at least the same population that receives the station's current analog and digital service so that over-the-air viewers will not lose TV service and (ii) it does not create impermissible interference to other stations or prevent other stations from making their transition.⁴

The Commission has previously found that the Station qualifies for a phased transition STA under those criteria.⁵ As explained in the original request for STA, operation of KZTV on Channel 18 neither causes impermissible interference to any other station, nor prevents any other station from making its digital transition. Moreover, an extension of the existing STA will ensure that viewers who currently receive the station's over-the-air broadcast continue to receive the Station with no service loss.

As Eagle Creek has previously noted, the Commission will also review requests for STA to permit a station to continue to operate using its pre-transition channel on a case-by-case basis.⁶ Under such a review, the station must demonstrate that such operation would provide digital service to a greater population that would [its] incomplete post-transition facility. Certainly permitting KZTV to continue to provide CBS Network service to over-the-air viewers using its current pre-transition Channel 18 facilities provides digital service to a significantly larger number of viewers than KZTV from its un-built post-transition Channel 10 facilities.

Under such a case-by-case review, the Commission has recognized that it "will continue to consider requests for extension of time where the station is awaiting action by the Commission ...

on a pending application ... or where action on an application is being delayed for other reasons beyond the station's control."⁷ In the instant case, the long-pending application to assign KZTV's license, the grant of which is beyond the Station's control, has further delayed the station's ability to finalize its digital transition given the competing transition plans developed by Eagle Creek and the propose assignee.

Eagle Creek has however continued to work closely with the proposed assignee and anticipates that the necessary equipment to permit KZTV's final conversion to its post-transition facilities will be ordered immediately.

Grant of an extension in KZTV's existing STA is in the public interest as it will allow the station to continue to provide valuable over-the-air CBS Network programming to viewers in the Corpus Christi, Texas market. By contrast, the failure to obtain the requested STA extension would likely result in the station having to cease providing any digital broadcast service at all.

For these reasons, Eagle Creek respectfully submits that the public interest strongly supports grant of this request for an extension of KZTV's existing phased transition STA, allowing it to continue to provide digital broadcast service on its pre-transition Channel 18 facilities and extend the Station's post-transition construction deadline.

Also enclosed is a completed FCC Form 159 for the credit card payment of the applicable \$170.00 filing fee and an executed Anti-Drug Abuse Certification.

Please date-stamp the enclosed "Return Copy" of this filing and return it to the courier delivering this package. A copy of this letter is being served on counsel for the petitioner to deny the pending KZTV license assignment application.


