

DECLARATION

1. I am Executive Vice President for Legal and Government Affairs of Pappas Telecasting Companies ("PTC"). PTC has filed an application before the Federal Communications Commission (the "FCC") for a construction permit for a low power television station to operate on Channel 63 in South Sioux City, Nebraska (File No. BNPTTL-20000831APO) (the "PTC Application").
2. John R. Powley ("Powley") has filed with the FCC an application in File No. BNPTTL-20000831AQD for a construction permit for a new low power television station to operate on Channel 62 in Sioux City, Iowa (the "Powley 62 Application") and Powley has filed with the FCC an application in File No. BNPTTL-20000831AQN for a construction permit for a new low power television station to operate on Channel 64 in Sioux City, Iowa (the "Powley 64 Application," and, together with the Powley 62 Application, collectively, the "Powley Applications").
3. Pursuant to an Application Dismissal Agreement by and between Powley and PTC (the "Settlement Agreement"), PTC has agreed to dismiss the PTC Application in exchange for the right to purchase from Powley a construction permit from the FCC authorizing the construction of a new low-power television station to operate on either Channel 62 or Channel 64 in Sioux City, Iowa for the sum of ten thousand dollars (\$10,000.00). An itemized accounting of the expenses for the PTC Application is set forth as Exhibit 1 hereto.
4. Except for the Settlement Agreement, there are no other agreements or understandings between PTC and Powley regarding the PTC Application or the Powley Applications. I certify that PTC has neither received nor been promised any consideration of any nature whatsoever, directly or indirectly, for the actions that it has agreed to take under the Settlement Agreement, except as set forth in the Settlement Agreement.
5. The PTC Application was not filed for the purpose of entering into the Settlement Agreement or any similar agreement.
6. Approval of the Settlement Agreement will serve the public interest by expediting the issuance of authorizations by the FCC for two new low power television stations in Sioux City, Iowa.
