\* The FCC has authorized subsidiaries of Raycom to hold television duopolies in the Hawaii DMA (KHNL, Honolulu, including its satellites, and KFVE, Honolulu) and in the

Cleveland DMA (WOIO, Shaker Heights and WUAB, Lorain). The FCC also has granted six-month temporary duopoly waivers permitting co-ownership of WACH and WIS in the Columbia, South Carolina DMA, WFXL and WALB in the Albany, Georgia DMA and WNWO-TV and WTOL in the Toledo, Ohio DMA (BTCCT-20050909ADC, et al).

**\*\*** KHBC-TV and KOGG operate as satellites of KHNL; and WTOM-TV operates as a satellite of WPBN-TV; and KTRE operates as a satellite of KLTN.

The FCC has granted its consent to assign the licenses of the following Raycom stations to subsidiaries of Barrington Broadcasting LLC (which transaction is scheduled to close shortly): WACH, Columbia, SC; WFXL, Albany, GA; WNWO-TV, Toledo, OH; KXRM-TV, Colorado Springs, CO; KTVO, Kirksville, MO; WLUC-TV, Marquette, MI; WPBN-TV, Traverse City, MI and its satellite WTOM-TV, Cheboygan, MI; WSTM-TV, Syracuse, NY; and KGBT-TV, Harlingen, TX.
