

**OTHER BROADCAST INTERESTS**

Buckley Broadcasting/WOR, LLC (“BBC/WOR”) has no other broadcast interests. BBC/WOR is wholly owned by its sole member, Buckley Broadcasting Communications (“BBC”),<sup>1</sup> which, in addition to BBC/WOR, holds an attributable interest in Buckley Broadcasting of Connecticut, LLC (“BBC-CT”) and Buckley Broadcasting of California, LLC (“BBC-CA”). BBC-CT and BBC-CA are the licensees of the following broadcast stations, respectively:

1. WSNB(AM), Torrington, Connecticut (FIN: 13716), WDRB(AM) and WDRB-FM, Hartford, Connecticut (FIN: 7711 and 7718), WWCO(AM), Waterbury, Connecticut (FIN: 40678), and WMMW(AM), Meriden, Connecticut (FIN: 1220) licensed to BBC-CT.
2. KNZR(AM), Bakersfield, California (FIN: 7715), KLLY(FM), Oildale, California (FIN: 7709), and KSMJ(FM), Shafter, California (FIN: 8109) licensed to BBC-CA.

Furthermore, various principals of BBC also hold interests in other stations, as detailed below.

Martha Buckley Fahnoe has the following broadcast interests:

1. Director, Vice President, Secretary, and 10.6% stockholder of Buckley Communications, Inc. (“BCI”), licensee of Stations KKBB(FM), Bakersfield, California (FIN: 7720), KIDD(AM), Monterey, California (FIN: 7721), and KHTN(FM), Planada, California (FIN: 20334); KWAV(FM), Monterey, California (FIN: 7714), KUBB(FM), Mariposa, California (FIN: 7707), and KSEQ(FM), Visalia, California (FIN: 7717); and KYZZ(FM), Salinas, California (FIN: 15197).
2. Director, Vice President, and Secretary of Buckley Broadcasting of the San Joaquin Valley (“BBC-SJ”), licensee of Station KIOO(FM), Porterville, California (FIN: 7708).
3. Vice President, Secretary, and Director of BBC;
4. Vice President and Secretary of BBC-WOR;
5. Vice President and Secretary of BBC-CT; and
6. Vice President and Secretary of BBC-CA.

<sup>1</sup> The shareholders of BBC are four family trusts, each of which holds a 25% interest in BBC. The trusts are as follows: 1.) Richard D. Buckley Article Third (A) Trust F/B/O/ Richard D. Buckley, Jr.; 2.) Richard D. Buckley Article Third (B) Trust F/B/O Martha B. Fahnoe; 3.) Richard D. Buckley Article Third (C) Trust F/B/O/ Steven Bradford Buckley; 4.) Richard D. Buckley Article Third (D) Trust F/B/O/ Dana Buckley. Richard D. Buckley, Jr. (deceased), Martha Buckley Fahnoe, Dana Buckley, and Steven Bradford Buckley are siblings.

Martha B. Fahnoe is also a trustee of the four family trusts that own BBC, as detailed further in Exhibit 16 below.

1. President and Director of BBC;
2. President of BBC-WOR;

Dana Buckley is a Director of BBC. In addition, Dana Buckley is a Trustee of the Richard D. Buckley Article Third (D) Trust F/B/O/ Dana Buckley, which holds a 25% interest in BBC as detailed further in Exhibit 16 below

Steven Bradford Buckley is a Director of BBC. In addition, Steven Bradford Buckley is a Trustee of the Richard D. Buckley Article Third (C) Trust F/B/O/ Steven Bradford Buckley, which holds a 25% interest in BBC as detailed further in Exhibit 16 below.

In addition to the transfer of interest that is the subject of the instant application and detailed in Exhibit 16 below, Constance H. Buckley is also the proposed Executor of the estate of her late husband Richard D. Buckley, Jr., and holds the following interests:

1. Chairman of the Board of Directors of BBC-SJ. The Estate of Richard D. Buckley, Jr., of which Constance H. Buckley is the proposed Executor, holds 100% of the interest of BBC-SJ.
2. Chairman of the Board of Directors of BCI. The Estate of Richard D. Buckley, Jr., of which Constance H. Buckley is the proposed Executor, holds an 88.9% interest in BCI.

3. The Estate of Richard D. Buckley, Jr. holds an 11% membership interest in BBC-CA.
