

**Exhibit 13-H Narrative**  
Section 74.1233(a)(1) Common Overlap  
Request for Mattoon Waiver

Frank G. McCoy (“McCoy”), licensee of FM translator W277CV, Facility ID No. 156555, Channel 277D, Waukegan, Illinois, hereby respectfully requests the Commission waive section 73.1233(a)(1), requiring overlap between the present and proposed FCC F(50,50) 60 dBμ contours of the translator for grant of a minor change application.

In accordance with the established requirements for the grant of a Mattoon Waiver<sup>1</sup>, the Commission has previously waived Section 74.1223(a)(1) where an applicant has demonstrated that it does not have a history of filing “serial” minor modification applications, the proposed facility is mutually exclusive with its licensed facility and the translator will rebroadcast an AM station as an AM fill-in translator. McCoy has no history of filing "serial" minor modification applications.

The W277CV facility has not been "hopped" and is operating from its original licensed transmitter site. The proposed W277CV would rebroadcast AM station WRRD(AM), Facility ID No. 70771, 1510 kHz, Waukesha, Wisconsin, as an AM fill-in translator. The proposed W277CV facility is mutually exclusive to the W277CV licensed facility. The attached map demonstrates that the proposed W277CV FCC F(50,10) 40 dBμ interfering contour overlaps with the current licensed W277CV FCC F(50,50) 60 dBμ contour. Both facilities specify operation on the same frequency, Channel 277D (103.3 MHz). The two facilities are mutually exclusive. Therefore it is believed this proposed modification is eligible for a waiver of Section 74.1233(a)(1) of the Commission's rules.
