OTHER AUTHORIZATIONS

Springfield Broadcasting Partners, an Illinois general partnership (“Assignor”), is the licensee of television stations WRSP-TV, Springfield, Illinois (Facility ID No. 62009), and WCCU(TV), Urbana, Illinois (Facility ID No. 69544).

On March 16, 2006, the FCC granted its consent to the assignment of the license of television station WFXB(TV), Myrtle Beach, South Carolina (Facility ID No. 9054) from GE Media, Inc. to Assignor (*See* BALCT-20060201AQE). This assignment has not yet been consummated. Upon FCC approval of the instant application, the licenses of WRSP-TV and WCCU(TV), and related assets, will be exchanged for the license of WFXB(TV), and related assets, to effect a like-kind exchange under Section 1031 of the Internal Revenue Code of 1986.

Assignor has two general partners, Springfield Independent Television Company, Inc. (“SITC”), which is the managing partner, and Bahakel Broadcasting Company (“BBC”). SITC is a wholly owned subsidiary of Jackson Telecasters, Inc. (“Jackson”), which is the licensee of the following radio stations:

Jackson also holds an attributable interest in television station WBBJ-TV, Jackson, Tennessee (Facility ID No. 65204).

Bahakel Communications, Ltd. (“Bahakel”), is the 100% owner of Jackson and accordingly holds attributable interests in the stations listed above. Bahakel also is the 100% owner of BBC. Through its interests in BBC and other subsidiaries, Bahakel also holds attributable interests in the following television and radio stations:
