**FCC Form 316**  
**Section III, Paragraph 5**

The instant application seeks FCC consent to the *pro forma* transfer of control of Spanish Television of Denver, Inc. (“Spanish TV Denver”), licensee of KTFD-DT (formerly, KTVJ), Boulder, Colorado (“Boulder Station”), and a wholly-owned subsidiary of St. Louis/Denver LLC (“Parent Company”), which will occur when one of the two existing owners of Parent Company, each with a 50% voting (negative controlling) interest, withdraws and the other becomes the 100% owner of Spanish TV Denver and its Boulder Station.

As reflected in the attached Annex A “Before” diagram, Parent Company is a joint venture owned by Transferor Roberts Brothers Broadcasting, L.L.C. (“Roberts Bros.”)<sup>1</sup> and Transferee Telefutura Television Group, Inc. (“Telefutura”).<sup>2</sup> Each of Telefutura and Roberts Bros. holds a 50% voting (negative controlling) interest in Parent Company. Parent Company has two separate, wholly-owned licensee subsidiaries:<sup>3</sup> Spanish TV Denver, licensee of the Boulder Station; and Roberts Broadcasting Company (“RBC”), licensee of WRBU(TV), East St. Louis, Illinois (“East St. Louis Station”).<sup>4</sup> Pursuant to the parties’ agreement to dissolve Parent

Company, Telefutera would obtain a direct 100% interest in Spanish TV Denver and its Boulder Station (the transaction subject to the instant FCC Form 316) and Roberts Bros. would obtain a direct 100% interest in RBC and its East St. Louis Station (a transaction subject to a companion FCC Form 316) being filed concurrently herewith).<sup>5</sup>

As reflected in the Annex B “After” diagram, upon consummation of the transaction that is the subject of the instant application and the companion application, Spanish TV Denver would become a wholly-owned subsidiary of Telefutera. Because the proposed change involves an existing owner with negative (50%) control acquiring positive control, because the FCC has approved the qualifications of that party on a long-form application,<sup>6</sup> and because the change does not introduce any new parties, the proposed transaction is properly the subject of FCC Form 316. *See, e.g., Barnes Enterprises, Inc., 55 FCC 2d 721, 725 n. 4 (1975).*



Telefutera would appoint all the directors of Spanish TV Denver, the licensee of the Boulder Station, and that Roberts Bros. would appoint all the directors of RBC, the licensee of the East St. Louis Station. Although there are minor differences in the economic interests held by the two owners, the voting interests are split 50/50.
