**** In granting the application of LIN TV to acquire control of the licensee of WJPX and its satellites WJWN-TV and WKPV, all Puerto Rico, the FCC ruled that the public interest was served by permitting LIN TV to maintain its rebroadcast agreement with WTIN, treating that station as a "satellite station" of WAPA-TV.
