EDUCATIONAL OBJECTIVE

Upon the consummation of the transactions set forth in the Merger Agreement, dated January 19, 2017 between IHR Educational Broadcasting, d/b/a Immaculate Heart Radio (“IHR”) and Starboard Media Foundation, Inc. (“Starboard”), Starboard, the surviving corporation, will operate the radio stations presently licensed to both Starboard and IHR under a new name, Immaculate Heart Media, Inc. (“IHM”). As previously reported to the Commission in conjunction with applications that Starboard filed to convert stations to non-commercial status (*see, e.g.*, File Nos. BML-20160714ACS, BML-20160926AFE and BML-20160928AHA), Starboard operates the not-for-profit radio service entitled “Relevant Radio” on numerous stations nationwide. Relevant Radio is a Catholic-inspired service, broadcasting 24 hours a day, 7 days a week, and 365 days a year with award-winning hosts and produces 85 hours of original educational programming each week. Relevant Radio’s programs educate listeners about many aspects of the Catholic faith, and lead them to a deeper understanding of that faith, with the goal of assisting listeners in applying that faith to their day-to-day lives. Following Commission approval to the application for consent to the assignment of the stations presently licensed to IHR to IHM (the “Stations”), Starboard (which will be named IHM following the consummation of this application) will operate the Relevant Radio service on those Stations.

Relevant Radio’s programs include “Father Simon Says,” which will air six days per week on the Stations. The program includes a thorough examination of the daily Scripture readings, helping listeners make a connection between the Old and New Testaments and develop a better appreciation of the teachings of the Bible. The program also provides listeners with a “word of the day,” designed to improve each person’s vocabulary. Another program, “Go Ask Your Father,” which also will air six times per week on the Stations, provides listeners with the opportunity to ask a priest questions related to Catholic Church history, the Bible, the saints, the Vatican, the meaning of specific prayers, and more. “On Call with Wendy Wiese,” which will air five times per week on the Stations, focuses on important issues, such as eating disorders and addictions. The show is aimed at families and provides useful advice from a Catholic perspective. Numerous other programs air on Relevant Radio during the broadcast day, which give listeners tools to experience spiritual growth, discuss topics of interest to today’s families and include interviews with newsmakers, elected officials, scholars, notable experts and clergy.

Relevant Radio also operates the “Chastity Initiative,” which reaches out to teenagers, young adults and parents with the important message of the dignity of all human beings, the risks of engaging in pre-marital sexual intimacy, the importance of fidelity in marriage and the virtue of self-mastery. Relevant Radio seeks to challenge young people to understand and commit themselves to living exemplary lives, as well as to provide the tools they need to be leaders for others.

Starboard has been providing listeners of numerous stations with Relevant Radio programming since the early 2000s. Starboard, which will be known as IHM following the consummation of this application, proposes to continue providing Relevant Radio service on the Stations following the grant of this application.
