OTHER ATTRIBUTABLE MEDIA INTERESTS

General Electric Company ("GE") wholly owns NBC Telemundo Holding Co., which is the single controlling shareholder of NBC Telemundo, Inc. ("NTI"). NTI in turn wholly owns NBC Telemundo License Co. ("LicenseCo"), which is the licensee or approved assignee of the full-power broadcast stations listed on Attachment A-1 hereto. LicenseCo owns all of the issued and outstanding stock of WKAQ Holdings, Inc., which in turn wholly owns WKAQ of Puerto Rico Holdings I, Inc. and WKAQ of Puerto Rico Holdings II, Inc., the general partners of Telemundo of Puerto Rico, which is the licensee of the stations listed on Attachment A-2 hereto. LicenseCo also owns all of the issued and outstanding stock of NBC License Company, which in turn is the sole shareholder of each of the licensees of the stations listed on Attachment A-3 hereto, including the Assignor. LicenseCo also is the general partner of Station Venture Operations, LP, licensee of the stations listed on Attachment A-4 hereto, and the sole member of Telemundo Las Vegas License LLC, which is the licensee of the station listed on Attachment A-5 hereto.

National Broadcasting Company Holding, Inc. ("NBC Holding"), which is wholly owned by GE, and NBC Universal, Inc. ("NBC Universal"), which is 80% owned by NBC Holding, have an attributable interest in NTI under the equity-or-debt-plus ("EDP") rule because they indirectly own greater than 33% of the total assets of NTI and serve as a major program supplier to the full-power broadcast stations owned or controlled by LicenseCo.¹

GE indirectly holds a 38.6% voting interest in ValueVision Media, Inc. ("ValueVision"), licensee of Television Broadcast Station WWDP, Norwell, MA. GE neither has nor exercises control of ValueVision by virtue of this ownership interest.

GE Capital Commercial Finance, Inc. ("GECF"), an indirect wholly owned subsidiary of GE, has provided a credit facility to Mega Communications, Inc. ("Mega"), which accounts for more than 33% of the total asset value of Mega. Mega owns and operates radio stations in various markets, including the markets identified below in which LicenseCo owns or controls television stations. In each case, there are at least 10 independent media voices in the relevant market, and the EDP interest therefore complies fully with the radio-television cross-ownership rule.

Philadelphia: Mega's Station WEMG, Camden, NJ, and LicenseCo's Station WCAU, Philadelphia, PA.

¹ Station KWHY-TV, Los Angeles, CA, licensed to LicenseCo, does not receive 15% or more of its programming from any GE-affiliated entity, but is located in the same market as other GE-owned broadcast stations.

Washington, DC: Mega's Stations WBZS, Prince Frederick, MD, and WKDL, Alexandria, VA, and LicenseCo's Station WRC-TV, Washington, DC.

Boston: Mega's Station WAMG, Dedham, MA, and ValueVision's Station WWDP, Norwell, MA; Mega's Station WLLH, Lowell, MA, and LicenseCo's Station WNEU, Merrimack, NH.

Hartford: Mega's Stations WLAT, New Britain, CT, and WNEZ, Manchester, CT, and LicenseCo's Station WVIT, New Britain, CT.

GECF also has provided a credit facility to Coast Radio Company, Inc. ("Coast"), which accounts for more than 33% of the total asset value of Coast. Coast owns and operates three radio stations in the San Francisco, CA market: KABL-FM, Walnut Creek, CA; KKIQ(FM), Livermore, CA; and KUIC(FM), Vacaville, CA. LicenseCo owns and controls two television stations assigned to the San Francisco Designated Market Area. Because there are more than 10 independent media voices in the San Francisco market, this EDP interest complies fully with the radio-television cross-ownership rule.

Duncan Ebersol has an attributable interest in the respondent based on his position as an officer of the respondent or one or more of its corporate affiliates. Mr. Ebersol and his spouse, Susan St. James, each owns 23.2% of the outstanding stock of Local Girls and Boys Broadcasting Corporation ("LGBBC"). LGBBC is the licensee of a 3,000 watt FM station, WZBG, Litchfield, CT. Mr. Ebersol and Ms. St. James are both Directors and Vice Presidents of LGBBC. Mr. Ebersol is not "actively" involved in management and operations of LGBBC.

Jay Ireland has an attributable interest in the respondent based on his position as an officer or director of the respondent or one or more of its corporate affiliates. Mr. Ireland is a trustee on the Board of Trustees of St. Lawrence University, licensee of WSLU(FM), Canton, New York. Mr. Ireland is not "actively" involved in management and operations. (Canton, New York, is located more than 200 miles from any station in which LicenseCo has an attributable interest.)

Claudio X. Gonzalez is a Director of Grupo Televisa, which has an attributable interest in Univision Television Group, Inc., licensee of several television stations. Mr. Gonzalez has certified that as a GE Board member, he will not participate in any Board discussions or voting with respect to any matter specifically concerning NBC or Telemundo broadcast station subsidiaries.
