JOINT REQUEST FOR APPROVAL OF SETTLEMENT

Glory Communications, Inc. ("GCI"), by its attorney, and Augusta Radio Fellowship Institute, Inc. ("ARF"), by their officers, hereby respectfully submit this Joint Request for Approval of Settlement. The parties respectfully request that the Commission (1) approve the attached Settlement Agreements in Exhibits A Through (B), dismiss the ARF application, and (3) grant the GCI application for Channel 286 at Columbia, South Carolina. This is a partial Settlement of MX Group Number 421. In support, the following is shown:

The parties are simultaneously filing their Settlement Agreements and Joint Request, in accordance with Selection 73.3525 of the Commission's Rules (see, Exhibit A).


Each agreement contains declarations pursuant to Section 311 of the Communications Act of 1934, as amended, and Sections 1.16 and 73.3525 of the Commission's Rules, that approval of this Settlement (1) will serve the public interest by eliminating the need for the Commission to go through the "fair distribution analysis" and point system analysis" and for litigation between the parties, thereby conserving scarce adjudicatory resources at the Commission; and (2) will enable the new Translator broadcast service to be provided to the residents of the Columbia, South Carolina, area at the earliest possible date.

All parties hereby certify that their respective applications were not filed for the purpose of reaching or carrying out a Settlement agreement. The dismissing applicant demonstrates that the amount to be paid by GCI does not exceed ARF's reasonable and prudent expenses incurred in the preparation, filing, and prosecution of its respective application.

Therefore, grant of this joint Request will be in the public interest, convenience and necessity, as it will result in a Permit to allow the construction of a new translator FM service to serve Columbia, South Carolina.

WHEREFORE, the parties urge: that this joint Request for Approval of Settlement Be **GRANTED**; that the attached Settlement Agreement **BE APPROVED**; that the application of ARF be **DISMISSED**; and that the application of GCI for a new Translator on Channel 286 (105.1) at Columbia, South Carolina, **BE GRANTED**.


