The following parties have attributable broadcast interests in or through other broadcast entities as well as the respondent.

BROADCAST INTERESTS OF ROBERT N. SMITH

- (1) Robert N. Smith owns 54.2% of the voting stock (and is the single majority shareholder) of Smith Broadcasting Group, Inc., which has the following media interests:
 - (a) General partner and owner of 59.02% of the partnership interests of Smith Broadcasting Partners, L.P. ("SBPLP"). SBPLP owns 100% of the voting stock of Sunrise Television Corp., which is the sole stockholder of STC Broadcasting, Inc., which in turn owns all of the stock of STC License Company, licensee of WEYI-TV, Saginaw, Michigan, KRBC-TV, Abilene, Texas; KACB-TV, San Angelo, Texas; WDTN(TV), Dayton, Ohio, KUMV-TV, Williston, North Dakota; KQCD-TV, Dickinson, North Dakota; KMOT(TV), Minot, North Dakota; KVLV-TV, Fargo, North Dakota; KFVY-TV, Bismarck, North Dakota WUPW-TV, Toledo, Ohio, and WPRI-TV, Providence, Rhode Island. ^{1/}
- (2) Robert N. Smith also has the following media interests:
 - (a) Ownership of 100% of the voting stock of Smith Television of Santa Barbara, Inc., which in turn is one of two general partners of Smith Broadcasting of Santa Barbara Limited Partnership, licensee of Stations KEYT-TV and KEYT(AM), Santa Barbara, California.
 - (b) Ownership of 52% of the voting stock of Smith Television Investment Company, which in turn owns 84.7% of the voting stock of Smith Television of New York, Inc., licensee of WETM-TV, Elmira, New York and WKTV, Utica, New York, and 91% of the voting interests of Smith Broadcasting of Vermont Holdings, LLC, which owns 100 percent of the voting interests of Smith Broadcasting of Vermont, LLC, the permittee of WFFF-TV, Burlington, Vermont. Smith Television of New York, Inc. also holds a 78.39% general partnership interest in Smith Broadcasting of Santa Barbara Limited Partnership, and is the sole stockholder of Smith Television Group, Inc., which in turn is the sole stockholder of Smith Television License Holdings, Inc., the licensee of KOLO-TV, Reno,

Nevada, KATN(TV), Fairbanks, Alaska, KJUD(TV), Juneau, Alaska, and KIMO(TV), Anchorage, Alaska.

Mr. Smith is an officer and director or manager of all the entities referred to above.

BROADCAST INTERESTS OF SANDY DiPASQUALE

Sandy DiPasquale is a limited partner and owns 21.31% of the partnership interests of Smith Broadcasting Partners, L.P. In addition, Mr. DiPasquale is an officer of Sunrise Television Corp., STC Broadcasting, Inc., and STC License Company. The ownership interests of each of these entities are described above under Robert N. Smith.

BROADCAST INTERESTS OF DAVID A. FITZ

David A. Fitz is an officer and director of Smith Broadcasting Group, Inc. Mr. Fitz is also an officer of Smith Television Investment Company, Smith Television of New York, Inc., Smith Television Group, Inc., Smith Television License Holdings, Inc., Smith Television of Santa Barbara, Inc., Sunrise Television Corp., STC Broadcasting, Inc., and STC License Company. Mr. Fitz owns a 9.84% limited partnership interest in SBPLP. The broadcast interests of these entities are described under Robert N. Smith.

BROADCAST INTERESTS OF MARGARET WILLIAMS

Margaret Williams is an officer of Smith Television License Holdings, Inc., Smith Television Group, Inc., Smith Television of New York, Inc., Smith Television Investment Company, Smith Broadcasting Group, Inc., Smith Television of Santa Barbara, Inc., and Smith Broadcasting of Vermont Holdings, LLC. In addition, Ms. Williams is an officer and a non-voting member of Smith Broadcasting of Vermont, LLC. The ownership interests of these entities are described above under Robert N. Smith.

BROADCAST INTERESTS OF DEBRA EGER

Debra Eger is an officer of Smith Broadcasting Group, Inc., Smith Television of Santa Barbara, Inc., Smith Television Investment Company, Smith Television of New York, Inc., Smith Television Group, Inc., Smith Television License Holdings, Inc., Smith Broadcasting of Vermont Holdings, LLC, and Smith Broadcasting of Vermont, LLC. The ownership interests of these entities are described above under Robert N. Smith.

BROADCAST INTERESTS OF JENNIFER SMITH'S LIVING TRUST

Jennifer Smith's Living Trust, of which Robert N. Smith is the sole Trustee, owns (i) 20.4% of the stock of Smith Broadcasting Group, Inc.; (ii) less than 1% of the stock of Smith Television of New York, Inc.; and (iii) 10.5% of the stock of Smith Television Investment Company. The ownership interests of these entities are described above under Robert N. Smith.

BROADCAST INTERESTS OF MICHAEL SMITH

Michael Smith is a director of Smith Television License Holdings, Inc., Smith Television Group, Inc., Smith Television of New York, Inc., and a manager of Smith Broadcasting of Vermont, LLC, and of Smith Broadcasting of Vermont Holdings, LLC. Michael Smith owns (i) 20.4% of the stock of Smith Broadcasting Group, Inc. (ii) less than 1% of the stock of Smith Television of New York, Inc.; and (iii) 11.5% of the stock of Smith Television Investment Company. The ownership interests of these entities are described above under Robert N. Smith.

BROADCAST INTERESTS OF NANCY KLEIN

Nancy Klein is an officer of Sunrise Television Corp., STC Broadcasting, Inc., and STC License Company. The ownership interests of these entities are described above under Robert N. Smith.

BROADCAST INTERESTS OF WILLIAM S. BANOWSKY, JR.

William S. Banowsky, Jr., is a director of Sunrise Television Corp., STC Broadcasting, Inc., and STC License Company. The ownership interests of these entities are described above under Robert N. Smith.

BROADCAST INTERESTS OF DR. WILLIAM CUNNINGHAM

Dr. William Cunningham is a director of Sunrise Television Corp., STC Broadcasting, Inc., and STC License Company, and is a proposed transferee of Sunrise Television Corp., which ultimately controls STC License Company. The ownership interests of these entities are described above under Robert N. Smith. Dr. Cunningham also is a director of Jefferson-Pilot Communications Co., which owns the following broadcast stations, according to recent Commission records: WBTV-TV, Charlotte, North Carolina; WWBT(TV), Richmond, Virginia; WCSC-TV, Charleston, South Carolina; WLYF(FM), Miami, Florida; WMXJ(FM), Pompano Beach, Florida; WAXY(FM), South Miami, Florida; KSON(AM)/-FM, KIFM(FM) and KBZT(FM), San Diego, California; KKFN(AM) and KYGO-FM, Denver, Colorado; KCKK(AM) & KQKS-FM, Lakewood, Colorado; KJCD(FM), Longmont, Colorado; WBT(AM), Charlotte, North Carolina; WLNK(FM), Charlotte, North Carolina; WBT-FM, Chester, South Carolina; WQXI(AM), Atlanta, and WSTR(FM), Smyrna, Georgia.

BROADCAST INTERESTS OF ANNE SMITH

Anne Smith is a director of Smith Broadcasting Group, Inc. The ownership interests of this entity are described above under Robert N. Smith.
