307(b) STUDY CITY OF LICENSE CHANGE STATEMENT KIDN-FM BURNS, COLORADO NRC BROADCASTING MOUNTAIN GROUP, LLC FCC FORM 301 OCTOBER 2009

The applicant, NRC Broadcasting Mountain Group, LLC ("NRC"), seeks to minor change its city of license for KIDN-FM (facility I.D. 57339) from Hayden, Colorado on channel 240C3, to Burns, Colorado on channel 240A.

The minor change of the city of license is pursuant to the new provisions of MB Docket 05-210 which became effective on January 19th, 2007. This docket allows for city of license changes, under certain provisions, to be filed as a minor change application on FCC form 301 for AM and FM broadcast stations.

NRC believes this application meets the provisions under this new docket for a change in authorized communities for this new station. The docket emphasizes the desire to avoid any losses of service to communities while providing the most efficient usage of spectrum.


FIGURE 1, PROPOSED GAIN AND LOSS AREAS KIDN BURNS, COLORADO, CHANNEL 240A

The current city of license for KIDN-FM, Hayden, Colorado, is well served by two other FM stations, KQZR(FM) Hayden, facility ID 84270, operating on channel 297C2, and by KHCO(FM) Hayden, facility ID 92359, operating on channel 211C2. Figure 1 shows a gain/loss study which shows the current 60 dBμ coverage contour of KIDN and the new proposed 60 dBμ coverage contour. Figure 2 shows that Hayden will continue to receive 16 primary signals from stations in the same or other communities (14 FM and 2 AM). The proposed new community, Burns, Colorado, does not have a commercial AM, FM, or TV station authorized to it. Therefore, it will be the

community's first local service. According to the 2000 U.S. Census, the population of Burns is 100 persons. Thus, the public interest supports a change of allotments from Hayden, Colorado, which will continue to receive local service from two other license FM stations, KQZR and KHCO, while Burns will benefit from its first local service. Figure 3 shows the overlaps with other primary services with the new proposed KIDN-FM at Burns, Colorado.

Under the Instructions for the FCC form 301, under item 18, it calls for the following information to be included:

- 1) If new technical facilities are proposed, the area and population with the proposed 70 dBμ and 60 dBμ contours of the station: In this case, the population within the current contours of the new station at Hayden is: 60 dBμ: 25,101 persons and an area of 4,525 sq. km., 70 dBμ: 15,740 persons and an area of 2,614 sq. km. The new proposed contours for the new station at Burns will be: 60 dBμ: 15,574 persons and an area of 1,592 sq. km, 70 dBμ: 4,258 persons and an area of 634 sq. km.
- 2) The number of stations licensed to the proposed new community of license: There is no commercial AM, FM, or TV station licensed to Burns, Colorado. This will be the community's first local service.
- 3) The number of stations providing protected service to the proposed community of license: There are 9 FM stations that cover the new community with 60 dBμ service or greater. There are 2 AM stations that cover the new community with 0.5 mv/m coverage or greater.

- 4) The population, according to the latest Census Data, of the proposed community of license: In this case, the community of Burns, Colorado, is 100 persons according to the 2000 U.S. Census data.
- 5) Where relevant to establish the precondition of a licensable community, a description of the civic, cultural, religious, social and commercial attributes of the proposed community of license: Burns, Colorado has its own post office with the zip code of 80426. It also it served by several commercial businesses and the Burns Baptist Church.
- 6) Any other information deemed relevant:






