TECHNICAL STATEMENT

1. This technical statement and attached exhibits were prepared on behalf of ABG Arkansas, LLC ("ABG"), proposed assignee of radio station KCDI, Channel 227A, Bryant, Arkansas.¹ ABG is also the licensee of KHTE-FM, Channel 243C3, England, Arkansas, and KLEC-FM, Channel 292C2, Lonoke, Arkansas.² The 3.16 mV/m contours of both the licensed and authorized permit for KCDI overlap with the 3.16 mV/m contour of KHTE-FM. Neither the licensed nor permitted contour of KCDI overlaps with the KLEC-FM contour. This results in ABG having common interests in two FM stations in the same market. Exhibit #1 is a map depicting the stations.

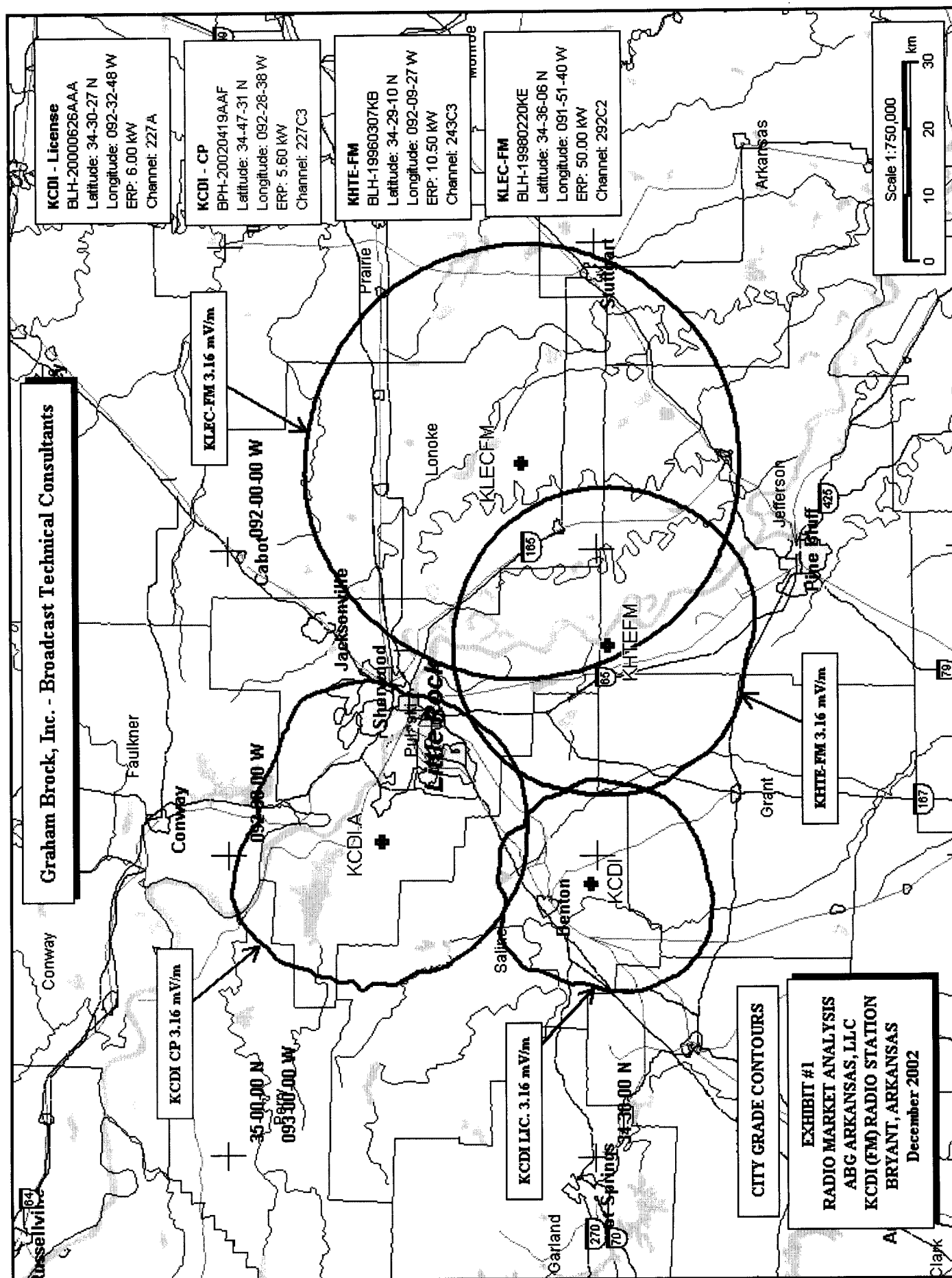
2. Therefore, a study has been conducted to determine if ownership of these facilities complies with §73.3555 of the Commission's rules. The study will determine the number of other commercial AM and FM stations that either have transmitter sites within, or provide coverage to, the subject Radio Market. Since the KHTE-FM contour overlaps with both the licensed and permitted KCDI contours, it will be used to establish the Radio Market boundary for this study.

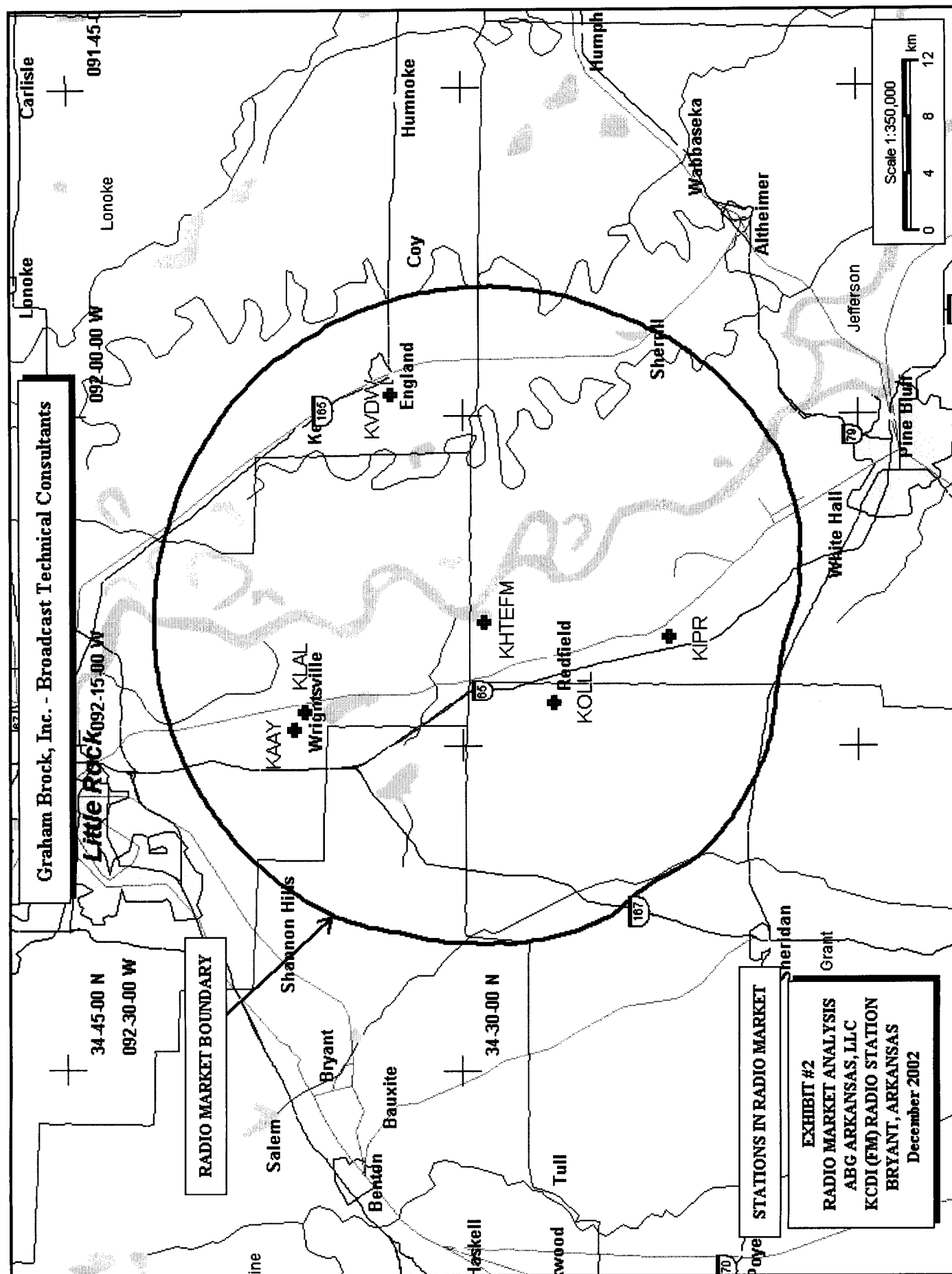

- 1) There is a recently granted permit authorizing a relocation and upgrade for KCDI to Class C3 (BPH-20020419AAF).
- 2) A Radio Market Analysis for KLEC-FM and KHTE-FM was submitted with that transfer application.

3. Exhibit #2 is a depiction of the stations in the Radio Market, showing five commercial AM and FM stations, including the two subject stations. Exhibit #3 is a tabulation of the stations in the Radio Market. The number of stations depicted falls in the fourteen or fewer stations tier of §73.3555(a)(1)(iv) of the Commission's rules.¹ At the fourteen or fewer stations level, common ownership or control of up to five stations, with no more than three in the same service, is permissible (provided the party does not control more than 50% of the stations in the Market). Therefore, ABG's interests in two FM stations in the same market are in compliance with the Commission's rules. Therefore, ABG's proposed ownership of KCDI is in compliance with §73.3555 of the rules.

1) Although there are additional stations providing service to the Radio Market, they are not considered since the number of stations was ample to demonstrate compliance with the rules based on the number of stations proposed to be commonly owned.
