Dear Ms. Fitzgerald:

This letter is written on behalf of my client, Aerco Broadcasting Corporation ("Aerco"), and is in response to a request from Paulette Laden of your staff to whom you have assigned this matter for processing. The purpose of this letter is to answer to two specific questions which you have posed to the applicant in the past and which were again directed to Aerco, through this office, as recently as December 8, 2004.

The pending application for involuntary transfer of control which was filed with the Commission sought permission to transfer control of Aerco from the Angel E. Roman ("Mr. Roman"), deceased to the decedent's estate which is represented by the decedent's two children- Angel O. Roman-Lopez ("Angel O.") and Ruth Evangeline Roman Lopez ("Ruth"). In connection with this application your staff has requested the following (1) proof that Mr. Roman's two adult children (listed in the application) are the only heirs to the estate and (2) evidence that Angel O. Roman-Lopez is the estate's personal representative.

With respect to the question of the identity of the decedent's surviving heirs, there is attached hereto an order entered by the Probate Court yesterday, December 22, 2004, establishing

that Angel O. and Ruth are Mr. Roman's sole surviving heirs. That order (referred to as a "Resolution") was issued by the Superior Court of San Juan and is attached hereto in its original Spanish language as well as with an English translation.

Under Puerto Rico law, if the decedent died leaving a will then the person named in that instrument is appointed as executor. Alternatively, if the decedent died without leaving a will naming an executor then the surviving heirs, as a group, comprise the estates' representatives and act, collectively, on behalf of the estate. Furthermore, the authority of one heir to act for the other (s) may be delegated by use of a Power of Attorney. In the case of Aerco, Mr. Roman, Aerco's sole shareholder, died intestate, so the estate's representatives consist of the two surviving heirs, Angel O. and his sister, Ruth. Already filed with the pending application, is the power of attorney wherein Ruth delegated authority to Angel to act on her behalf. Accordingly, Angel O. Roman has the full authority to act on behalf of the heirs of the Estate.

The documents already submitted with the application, together with the attached, should answer the questions which existed and delayed action on the application. I hope that we have been responsive, finally, to the concerns of you and your staff. If you would like to have this explanation, and the attached court order, filed as an amendment to the application, I can arrange that to be done on Monday. Furthermore, if it would be helpful to have an annotated explanation of the probate law applicable to this estate provided by local counsel I can have that provided next week.

I understand that Ms Laden will not be returning to work until next week, however, in her absence should you have any questions with respect to this letter or the application, please contact me. I would like to discuss this application, in light of the foregoing, with either you or Ms. Laden at you convenience.


