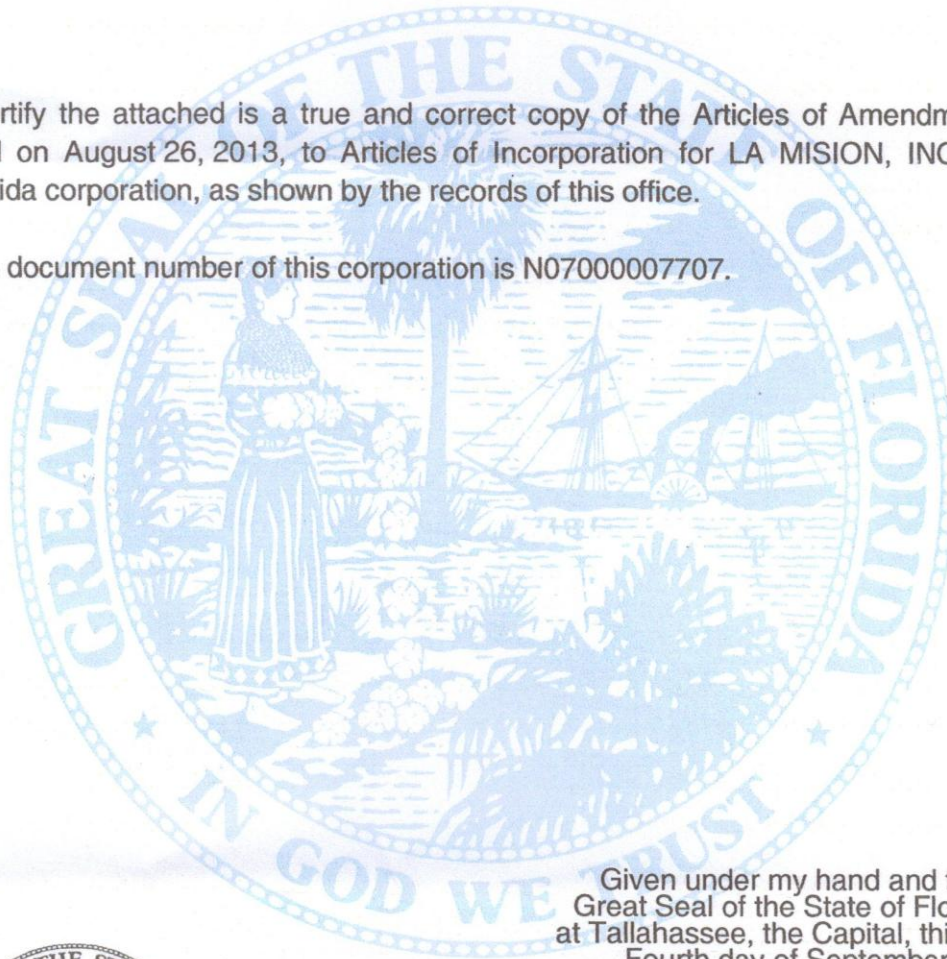

Further, this corporation will be involved in the production and dispersion of educational and religious media, and the transaction of any or all lawfull business for which may be conducted by such enterprise.

-We will provide a publicly accessible main studio with local programming origination capability, staffed with volunteers working 20 or more hrs per week between 7 am-10pm (at minimum), and within 10 miles of proposed transmitting antenna site.

-This Corporation will require 75% of the total board membership (directors) to be held by members that reside within 10 miles of proposed transmitting site.
