**AMENDED PETITION FOR DECLARATORY RULING**

Univision Holdings, Inc. (“Univision”), Searchlight III UTD, L.P. (“Searchlight Aggregator”), ForgeLight Univision Holdings LLC (“ForgeLight Holdings”), Multimedia Telecom, S.A. de C.V. (“Multimedia Telecom”), and Liberty Global Incorporated Limited (“Liberty Global”) (collectively, “Petitioners”), by their attorneys, respectfully submit this petition (“Petition”) requesting that the Federal Communications Commission (the “FCC” or the “Commission”) issue a declaratory ruling to allow Univision to have foreign investment in excess of the 25% benchmark contained in Section 310(b)(4) of the Communications Act of 1934, as amended (the “Communications Act”).<sup>1</sup> Specifically, Petitioners seek a ruling permitting up to 100% aggregate foreign investment (voting and equity) in Univision, which is the indirect parent company of 46 licensee subsidiaries that hold broadcast television and radio and other FCC licenses.<sup>2</sup> In addition, Petitioners request specific approval for (1) certain identified foreign entities

and individuals to hold, directly or indirectly, equity and/or voting interests of more than 5% in Univision and (2) certain identified foreign entities insulated in accordance with the FCC's rules, to hold, directly or indirectly, equity and/or voting interests of more than 10% in Univision.<sup>3</sup>

## **I. BACKGROUND**

Univision, the leading media company serving U.S. Hispanics, is the ultimate parent company of broadcast licensees that own and operate 65 full-power and low-power television stations and 58 radio stations located throughout the United States and Puerto Rico pursuant to

Although the insulated parties will not actually hold any voting rights because of their insulated status, Petitioners have treated these insulated entities as having a voting interest that is equivalent to their equity interest in Univision for purposes of this Petition. *See id.* § 1.5002(b)(2)(ii)(B). Except as otherwise specifically disclosed herein, Petitioners confirm that no foreign individual or entity who is insulated will hold, directly or indirectly, an equity and/or voting interest of more than 10% in Univision.

licenses issued by the Commission. Univision is a privately held Delaware corporation currently owned by a group consisting of several private equity investors (collectively, the “Investor Group”), Multimedia Telecom (which is a subsidiary controlled by Grupo Televisa, S.A.B., a Mexican corporation (“Televisa”)),<sup>4</sup> certain bank investors (the “bank investors”) and certain members of Univision management. Univision has three separate classes of common stock currently outstanding: Class A (voting), Class B (non-voting), and Class C (voting).<sup>5</sup>

In 2017, the Commission issued a declaratory ruling permitting (i) aggregate foreign ownership of up to 49% of Univision’s equity and voting interests and (ii) Televisa and its affiliates to hold up to 49% of Univision’s equity and 40% of its voting interests.<sup>6</sup> In December 2019, in order to accommodate a pro forma internal restructuring of one of Univision’s indirect, wholly-owned subsidiaries, the Commission granted a request to modify the *2017 Declaratory Ruling*, increasing the permissible aggregate amount of foreign ownership of Univision to up to and including 70% of the company’s equity and voting interests.<sup>7</sup> In doing so, the Commission maintained the specific approval granted to Televisa to hold up to 49% of Univision’s equity and 40% of its voting interests.

## **II. THE CIRCUMSTANCES PROMPTING THE FILING OF THE PETITION**

The circumstances prompting the filing of this Petition are described below and are collectively referred to herein as the “Transaction.” Pursuant to a Stock Purchase Agreement dated February 24, 2020 (the “Agreement”), the members of the Investor Group have agreed to sell all of their shares of Univision Class A and Class B common stock to Searchlight Aggregator. In connection with the Agreement, Searchlight Aggregator has agreed to assign a portion of its right to acquire these shares to ForgeLight Holdings.

The Investor Group collectively holds Class A common stock currently representing approximately 77.09% of Univision’s outstanding voting stock, and Class A and Class B common stock currently representing approximately 82.7% of Univision’s outstanding equity. At this time, Televisa, through its subsidiary Multimedia Telecom, holds (i) Class C common stock representing approximately 14.2% of Univision’s outstanding voting stock and 9.75% of its outstanding equity and (ii) warrants which Televisa intends to exercise at or shortly after the closing of the Transaction, which will bring Multimedia Telecom’s ownership after the Transaction up to 40.83% of Univision’s voting stock and 36.1% of its outstanding equity. The shares of Class A, Class B and/or Class C common stock held by management of Univision and the bank investors collectively represent approximately 4.3% of Univision’s voting stock and 3.0% of its outstanding equity. As part of the Transaction, the bank investors and management stockholders will also sell their shares to Searchlight Aggregator. Immediately prior to the acquisition of all of the outstanding common shares of Univision not held by Multimedia Telecom (the “Purchased Shares”), as part of the Transaction, Searchlight Aggregator will assign a portion of its right to make such acquisition to ForgeLight Holdings, and ForgeLight Holdings will participate in the acquisition of the Purchased Shares alongside Searchlight Aggregator.

In addition, pursuant to a subscription agreement, Univision will issue 100,000 shares of non-voting Series A Participating Convertible Preferred Stock, constituting an 11.6% equity interest in Univision following the closing of the Purchased Shares (and taking into account the exercise of the Televisa warrants), to Liberty Global and, substantially concurrently with such issuance, Univision will repurchase and cancel a portion of the Purchased Shares equivalent to the purchase price paid by Liberty Global for the Series A Participating Convertible Preferred Stock.<sup>8</sup>

The Agreement also contemplates, pursuant to a governance term sheet appended thereto, that post-closing Univision will be governed by a 9-member board of directors. Each of Searchlight Aggregator, ForgeLight Holdings and Televisa (through Multimedia Telecom) will, immediately following the closing, have the right to designate a certain number of board members as follows: Searchlight Aggregator – 4 members; ForgeLight Holdings – 2 members; and Televisa – 3 members.<sup>9</sup>

After closing of the Transaction and the exercise of the Televisa warrants, the equity and voting interests of Univision would be as follows:

Searchlight Aggregator	26.2% equity and 29.65% voting
ForgeLight Holdings	26.1% equity and 29.52% voting

No new warrants are being issued as part of the Transaction. The respective voting percentages have been determined based on the number of voting shares that will be held by each of Searchlight Aggregator, ForgeLight Holdings and Televisa (following the proposed exercise of the Televisa warrants).<sup>10</sup> If calculated instead based on the percentage of board members that each party will be entitled to designate, Searchlight Aggregator would hold 44%, ForgeLight Holdings would hold 22%, and Televisa (through its subsidiary Multimedia Telecom) would hold 33% of Univision's voting interests.

In view of the ownership changes that will occur as a result of the proposed Transaction, the Petitioners respectfully request a declaratory ruling (i) increasing Univision's authorized aggregate foreign ownership up to and including 100% of the company's equity and voting interests and (ii) granting specific approval for those new foreign investors identified herein.

Applications on FCC Form 315 seeking Commission approval for the transfers of control of the broadcast television and radio licenses involved in the proposed Transaction (as well as applications for the Commission's consent to the transfers of control of various non-broadcast FCC licenses associated with the television and radio stations) are being filed concurrently with this

Petition. Accordingly, Petitioners are timely filing the instant Petition pursuant to 47 C.F.R. § 1.5000(a)(1).<sup>11</sup>

### **III. DESCRIPTION OF THE PETITIONERS**

#### **A. Searchlight Aggregator**

Searchlight Aggregator, a Delaware limited partnership, is a special purpose vehicle that is acting as an aggregator of a group of investment funds affiliated with Searchlight Capital Partners, L.P. (“Searchlight”), a registered investment adviser with the United States Securities and Exchange Commission.<sup>12</sup> Searchlight, a Delaware limited partnership, is a global private equity investment company, whose funds invest in companies across various sectors, including communications, media, consumer and business services. Searchlight is controlled by its three founding partners: Eric Zinterhofer, a U.S. citizen; Erol Uzumeri, a Canadian citizen; and Oliver Haarmann, a German citizen.

Although Searchlight is deemed to be an affiliate of Searchlight Aggregator and the investment funds because of their common control, it has no direct or indirect ownership interest in Searchlight Aggregator (or in Univision), and has no authority to make any decisions on behalf of Searchlight Aggregator or the investment funds. Accordingly, Searchlight is not a party to the FCC Form 315 applications and is thus not a party to this Petition.

The general partner (0% equity/100% voting) of Searchlight Aggregator is Searchlight III UTD GP, LLC, a Delaware limited liability company (“Aggregator GP”). The sole member (100% equity/100% voting) of Aggregator GP is Searchlight Capital Partners III GP, L.P., a Cayman Islands exempted limited partnership (“Searchlight III GP”), which, in turn, is controlled by its general partner (0% equity/100% voting), Searchlight Capital Partners III GP, LLC, a Delaware limited liability company (“Upper GP”).<sup>13</sup> Upper GP is controlled by Messrs. Zinterhofer (33.3% equity and voting), Uzumeri (33.3% equity and voting), and Haarmann (33.3% equity and voting).

The limited partners of Searchlight Aggregator, all of which are insulated in accordance with the FCC’s rules,<sup>14</sup> are the following three Searchlight investment funds, which collectively will hold 100% of the equity in Searchlight Aggregator: SC III UTD, L.P., a Cayman Islands exempted limited partnership (“Main AIV Splitter”); Searchlight Capital III PV (FC) AIV, L.P., a Delaware limited partnership (“PV AIV”); and Searchlight Capital III UTD Co-Invest Partners, L.P., a Delaware limited partnership (“Co-Invest Vehicle”). The exact amounts of equity that each fund will hold upon consummation of the Transaction has not yet been determined, but will depend on the amount of the overall investment to be held by Co-Invest Vehicle. It is anticipated that the total amount of equity each fund will hold in Searchlight Aggregator will be within the following ranges: Main AIV Splitter – 36.9% to 43.1%; PV AIV – 29.8% to 34.7%; and Co-Invest Vehicle – 22.2% to 33.3%.

The limited partners of the Main AIV Splitter are SC III UTD Holdings, Ltd., a Cayman Islands corporation (“Main AIV Blocker”) and Searchlight Capital III (FC) AIV, L.P., a Delaware

limited partnership (“Main Fund AIV”). Main AIV Blocker is wholly-owned by Main Fund AIV. Searchlight III GP is the general partner (0% equity/100% voting) of both Main Fund AIV and Main AIV Splitter. The limited partners of Main Fund AIV are insulated in accordance with the FCC’s rules and none will hold an indirect equity (or deemed voting) interest in Univision or its licensee subsidiaries of more than ten percent. Searchlight III GP is also the general partner (0% equity/100% voting) of PV AIV and Co-Invest Vehicle. The limited partners of PV AIV and Co-Invest Vehicle are insulated in accordance with the FCC’s rules and none will hold an indirect equity (or deemed voting) interest in Univision or its licensee subsidiaries of more than ten percent.<sup>15</sup>

In view of the ownership structure described above, specific approval is sought for the foreign Searchlight entities and individuals identified in Attachment E to hold, directly or indirectly, equity and/or voting interests of more than 5%, or with respect to certain insulated entities, 10% or more in Univision. Although these entities will not actually hold any voting

rights because of their insulated status, Petitioners have treated these insulated entities as having a voting interest that is equivalent to their equity interest in Univision for purposes of this Petition.<sup>16</sup>

**B. ForgeLight Holdings**

ForgeLight Holdings, a Delaware limited liability company, is wholly-owned by ForgeLight (United) Investors, LLC, a Delaware limited liability company (100% equity and voting). ForgeLight (United) Investors, LLC, is a special purpose vehicle focused on the media and consumer technology sectors. The managing member of ForgeLight (United) Investors, LLC is ForgeLight (United) Investors MM, LLC, a Delaware limited liability company (0% equity/100% voting). The other members of ForgeLight (United) Investors, LLC include: WCD Services LLC, a Delaware limited liability company (15.5% equity/0% voting); ForgeLight (United) Investors SM, LLC, a Delaware limited liability company which will not hold any equity or voting interests but will have a 15% profit interest in ForgeLight (United) Investors, LLC; and other passive members insulated in accordance with the Commission's rules.<sup>17</sup>

Wade Davis, a U.S. citizen, is the sole member (100% equity and voting) of each of ForgeLight (United) Investors MM, LLC; WCD Services LLC; and ForgeLight (United) Investors

SM, LLC. All of the individuals and entities holding attributable equity and/or voting interests within the ownership structure of ForgeLight Holdings are U.S. citizens or domestic companies. All non-attributable individuals and entities within the ownership structure of ForgeLight Holdings are insulated. No such non-attributable individual or entity holds, or would hold, directly or indirectly, an equity or voting interest of more than 10% in Univision or its licensee subsidiaries. Accordingly, no specific approval is sought for any foreign individual or entity within the ForgeLight Holdings ownership structure; however, such foreign interests are included in the calculation of Univision's aggregate foreign ownership specified in Attachment C hereto.

**C. Televisa**

Televisa is a leading media company in the Spanish-speaking world that has provided Spanish language programming to audiences in the United States for decades. Multimedia Telecom is owned by Televisa (99.99% equity/24.03% voting) and Grupo Bissagio, S.A. de C.V., a Mexican corporation (0% equity/75.97% voting). Grupo Bissagio, S.A. de C.V. is controlled by Grupo Telesistema, S.A. de C.V., a Mexican corporation (99.99% equity/99.99% voting), which, in turn, is owned by Televisa (99.997% equity/99.997% voting). The Azcárraga Trust holds a 43.8% voting interest and a 15.1% equity interest in Televisa. Emilio Fernando Azcárraga Jean, the Executive Chairman of the Board of Directors of Televisa and a Mexican citizen, is the Trustee and beneficiary of The Azcárraga Trust, and personally holds an additional 1.84% voting interest and 0.63% equity interest in Televisa.

In view of the ownership structure described above, specific approval is sought for the foreign Televisa entities and individuals identified in Attachment E to hold, directly or indirectly, equity and/or voting interests of more than 5% in Univision.

**D. Liberty Global**

Following the completion of the Transaction, Liberty Global, a private limited company organized under the laws of England and Wales, will directly hold non-voting convertible preferred stock, but will not hold any voting interest in the company. Liberty Global is a direct, wholly-owned subsidiary of Liberty Global plc, a public limited company also organized under the laws of England and Wales. Liberty Global plc is an international broadband, television and telecommunications company providing broadband Internet, video, telephony, and mobile services to residential and business customers in certain European countries. The operating subsidiaries of Liberty Global plc pass over 25 million homes and have over 10 million fixed line customer relationships, with over 25 million revenue generating units. In view of the ownership interest described above, Petitioners seek specific approval for both Liberty Global and Liberty Global plc, as set forth in Attachment E, to hold, directly or indirectly, equity interests of more than 5% in Univision.

**IV. THE PROPOSED FOREIGN OWNERSHIP IS CONSISTENT WITH COMMISSION PRECEDENT AND THE PUBLIC INTEREST**

**A. Standard of Review and Public Interest Analysis**

Under the revised foreign ownership rules adopted in 2016, the FCC reviews requests by broadcast licensees to exceed the Communications Act's 25% indirect foreign ownership benchmark under the same streamlined standard that had historically applied to common carriers.<sup>18</sup> Specifically, under Section 310(b) and the FCC's rules, the agency will approve indirect foreign

ownership of broadcast licensees above 25% “unless the Commission finds that the public interest will be served by refusing to permit such foreign ownership.”<sup>19</sup>

In adopting rules to govern the consideration of broadcaster parent company requests for approval of up to 100% foreign voting and equity, the FCC rightly recognized “the need to provide broadcasters, as well as those seeking to acquire ownership interests in broadcasters, greater clarity and certainty” in an effort to “help improve access to capital from foreign investors and promote regulatory flexibility.”<sup>20</sup> Permitting greater foreign investment in broadcast parent companies “has the potential to spur new and increased opportunities for capitalization for broadcasters” which “may in turn yield greater innovation.”<sup>21</sup> Further, the FCC has previously determined that affording additional flexibility to structure foreign investments in Commission licensees “will promote U.S. trade policy.”<sup>22</sup>

As demonstrated below, the declaratory ruling sought herein would further each of these relevant policy objectives without compromising the FCC’s important interests in national security, law enforcement, or foreign and trade policy. Petitioners acknowledge, moreover, that the Commission’s grant of the relief requested in this Petition would be subject to the requirement that Univision obtain specific approval in the future for new foreign investment in Univision (or

increases in foreign investment by then-existing investors in Univision) that would result in any foreign entity holding a direct or indirect voting or equity interest above 5% (or above 10% for passive investors) other than as otherwise specifically approved by the Commission in connection with this Petition.

As a leading Hispanic media company, Univision entertains, informs, and empowers U.S. Hispanic audiences with news, sports, and entertainment content across broadcast and cable television, radio and digital platforms. Univision provides valuable programming services to a growing audience, with recent highlights including:

- Ranking among the top five broadcast networks in prime time with Hispanic adults 18-49 for the 16th consecutive year;
- Having the fastest growing portfolio of networks in prime time, regardless of language, among the top-10 U.S. media holders, in the fourth quarter of 2019;
- UniMás, Univision’s second broadcast network, with a 41 percent prime time audience growth during the first quarter of 2020 versus prior period;
- Airing 61 top soccer matches—as the home of soccer in the U.S., regardless of language;
- Successfully launching the Cuenta Conmigo (Count with Me) and Vota Conmigo (Vote with Me) civic engagement programs; and
- Keeping communities informed during the current coronavirus pandemic, including by:
  - Creating new local content for TV and radio stations, including live “Ask Dr. Juan” segments (run 160 times/day across all radio stations);
  - Airing a daily one-hour informative program across the Univision network, produced by the network in partnership with local stations; and



- Airing over 10,000 public service announcements per week on the TV stations and over 18,400 public service announcements per week on the radio stations.

Univision has been serving the Hispanic community in the United States for decades and has extensive knowledge and experience providing local broadcasting to its markets, both large and small. During this crucial time for the media industry and the communities it serves, Univision will benefit significantly from the Petitioners' proven leadership and record of innovation.

The Petitioners are dedicated to continuing Univision's history of service to its communities and to Hispanic America as a whole. Petitioners expect to support those efforts with investments that will enable the Univision networks and stations to better serve the public. For example, Univision has been a key member of the Phoenix and Dallas test markets experimenting with the deployment of the next generation broadcast standard, ATSC 3.0. Univision has served as a "lighthouse" station in both markets, meaning that it plays the critical role of airing its own and other broadcasters' streams in ATSC 3.0, and interfaces with the Commission in obtaining the appropriate licenses and authorizations. Univision plans to participate in ATSC 3.0 tests in other markets, remaining on the front lines of bringing the significant benefits of this standard to its viewers. The Petitioners will continue to support Univision's important role in this process.

The Petitioners will also seek to build on Univision's recent content and programming momentum to accelerate growth and substantially enhance Univision's digital presence, creating the opportunity for Univision to enter a new era of growth and innovation. Univision's digital sites have been a key part of its coronavirus awareness programming, featuring Spanish-language original content as well as streaming the Univision Network's informative programming.

First, the new ownership group will be led by Wade Davis as CEO of Univision, who has years of experience managing the growth and transformation of large-scale media enterprises. Mr.

Davis is a veteran in the media and technology industry, having been an investment banker, investor, entrepreneur, and senior operating executive for more than two decades. Mr. Davis was most recently CFO of Viacom and is a proven executive in advanced advertising and digital content distribution.<sup>23</sup> For example, Mr. Davis helped lead Viacom's efforts to embrace an ever-changing media landscape by diversifying its advertising and digital content distribution strategies, adapting those strategies to new viewership patterns and shaping new paths to connect brands to consumers. Among other achievements under Mr. Davis's leadership, Viacom launched direct-to-consumer subscription and advertising-based video on demand services,<sup>24</sup> expanded distribution across social media platforms,<sup>25</sup> and struck pioneering carriage and licensing deals in markets worldwide with an array of distributors,<sup>26</sup> including traditional linear players, new online

platforms, and mobile wireless carriers. Mr. Davis is eager to bring his track record of leadership and success in the media industry to Univision.

Second, the new ownership group will be backed by Searchlight's significant experience as a long-term investor in the media and communications sectors. Among other relevant investments, funds affiliated with Searchlight and ultimately controlled by Eric Zinterhofer and Andrew Frey have particular experience in the Spanish-language media and communications sectors through their investment in Hemisphere Media Group.<sup>27</sup>

Finally, Televisa will continue to serve as a key strategic partner to the new ownership and management team. Televisa has been a key strategic partner to Univision for decades, providing Univision with the exclusive U.S. broadcast and digital rights (with limited exceptions) to all of Televisa's programming, including premium Spanish-language dramas, sports, sitcoms, reality series, entertainment talk programming and feature films – the largest Spanish-language video library in the world. Televisa's Program License Agreement with Univision will remain in effect

and will not expire unless Televisa voluntarily sells down a substantial portion of its ownership stake, at which point the agreement would remain in place for an additional seven-and-a-half years.

In sum, as demonstrated above and herein, a grant of this Petition will provide the benefits of foreign investment to Univision contemplated by the Commission in the *2016 Foreign Ownership Order* and prior orders without raising any countervailing national security or law enforcement risks.<sup>28</sup>

### **Estimate of Aggregate Foreign Ownership**

Set forth in this attachment is the information required by Section 1.5001(h)(1) of the Commission's Rules. Petitioners estimate that foreign ownership of the capital stock in Univision Holdings, Inc. following a grant of this Petition and consummation of the Transaction and exercise of the Multimedia Telecom warrants would be as follows:

- Aggregate direct and/or indirect foreign equity interests: 69.13% - 77.85%
- Aggregate direct and/or indirect foreign voting interests: 74.43%

This estimate is based upon direct inquiry of the entities that will hold direct and/or indirect ownership interests in Univision and calculations by the Petitioners' representatives. The equity range fluctuations in this calculation are due to the fact that the exact amounts of equity that each Searchlight Aggregator fund will hold upon consummation of the Transaction has not yet been determined. These numbers will ultimately depend on the amount of the overall investment to be held by the Co-Invest Vehicle. However, the ranges listed above account for either no foreign investment in the Co-Invest Vehicle, or 100% foreign investment in the Co-Invest Vehicle. Specifically, the foreign equity "low end" of the range achieved a sum of 69.13% by adding the following equity percentages:

- Televisa (through Multimedia Telecom): 36.10%
- Liberty Global: 11.60%
- ForgeLight Holdings: 3.95%<sup>36</sup>

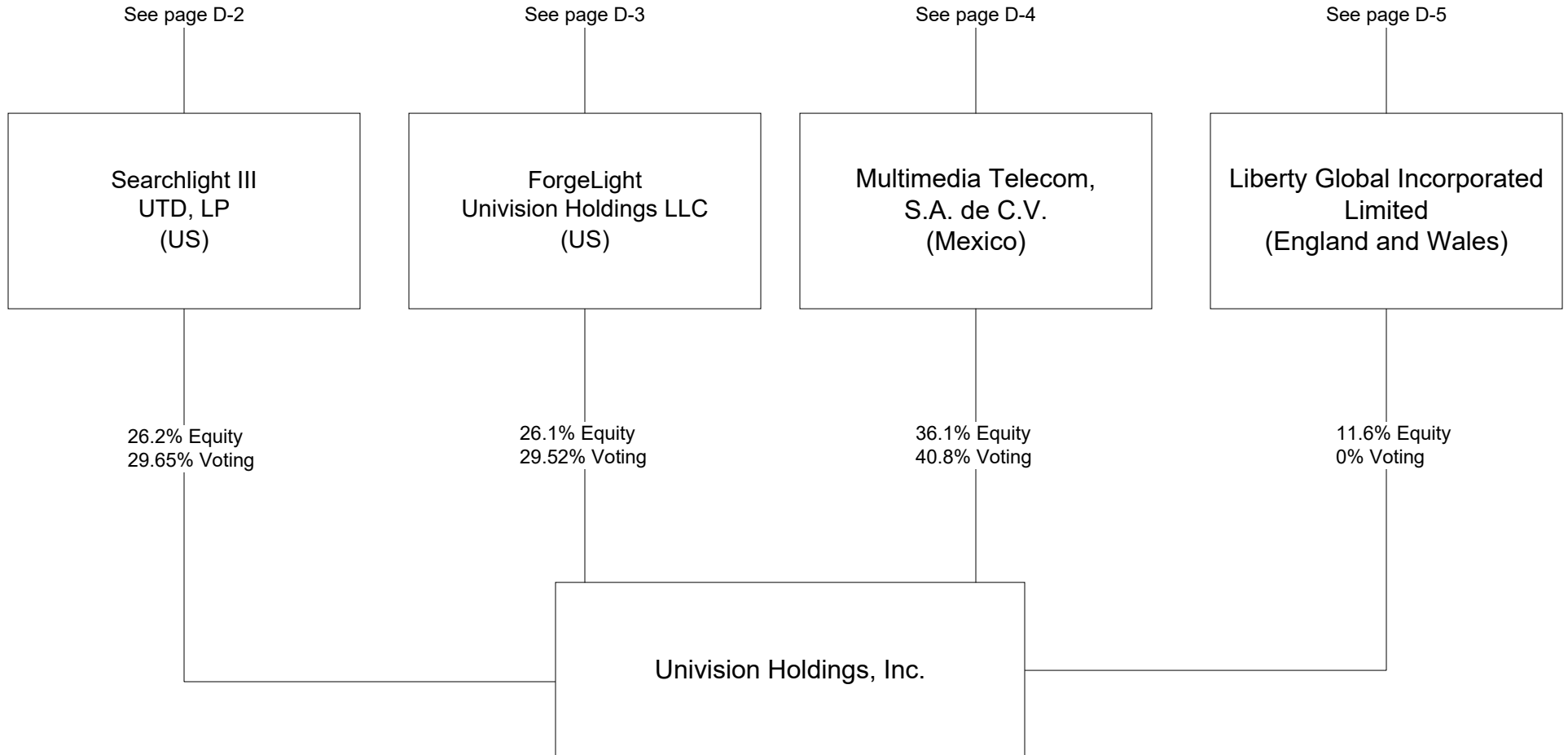

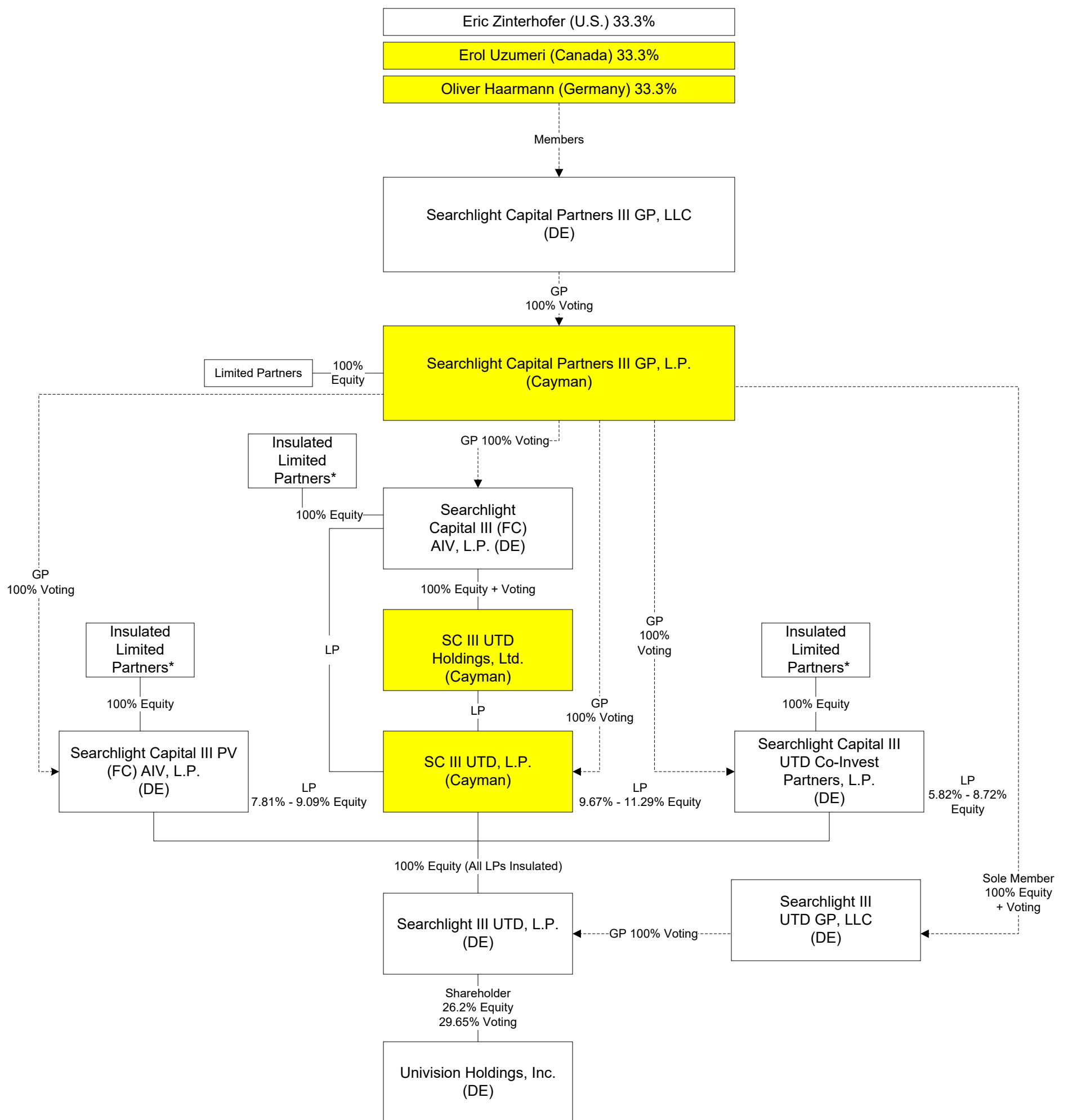
**Ownership Structure Chart**

## Post-Declaratory Ruling Ownership Structure Searchlight's Interest in Univision Holdings, Inc.



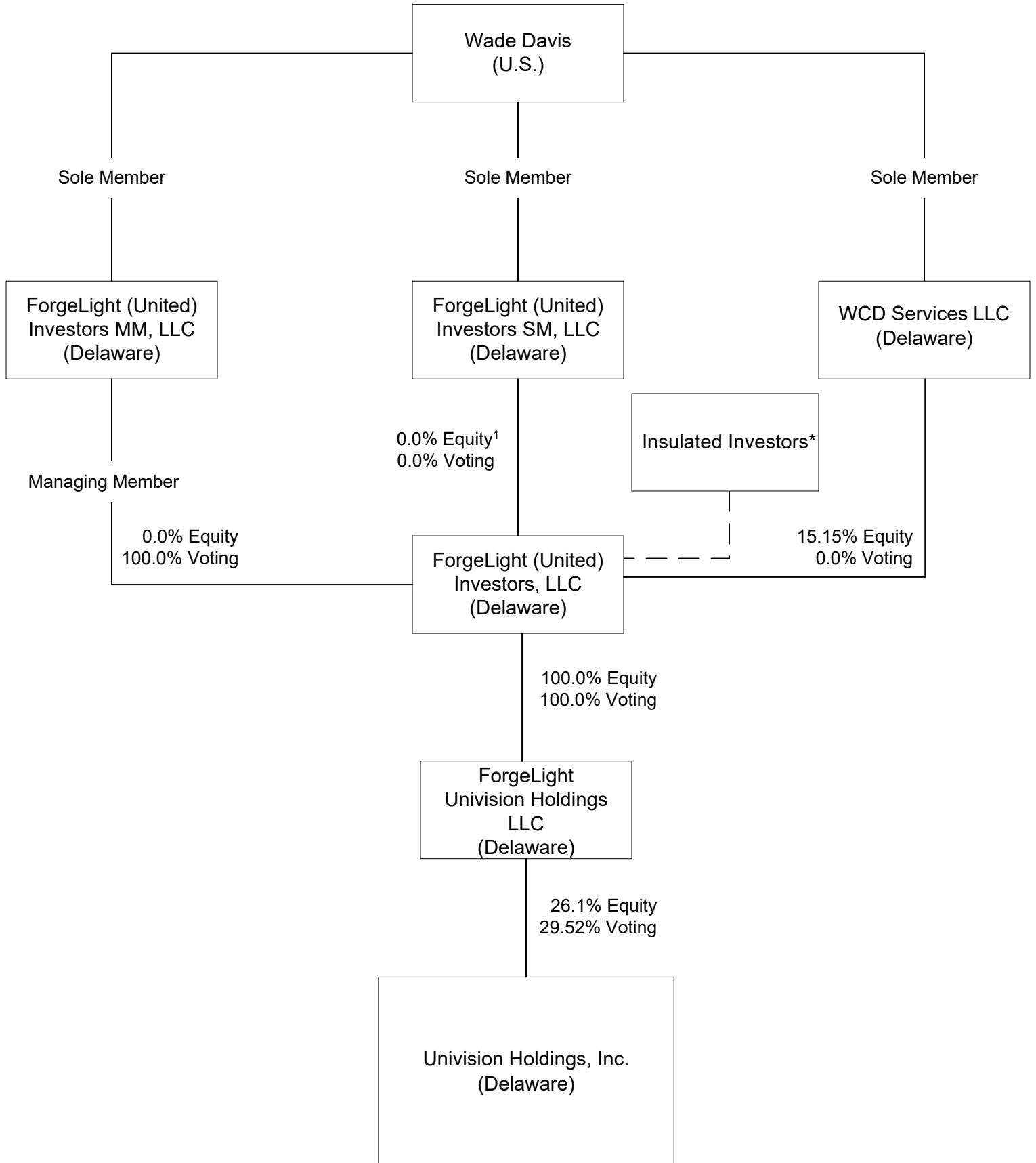

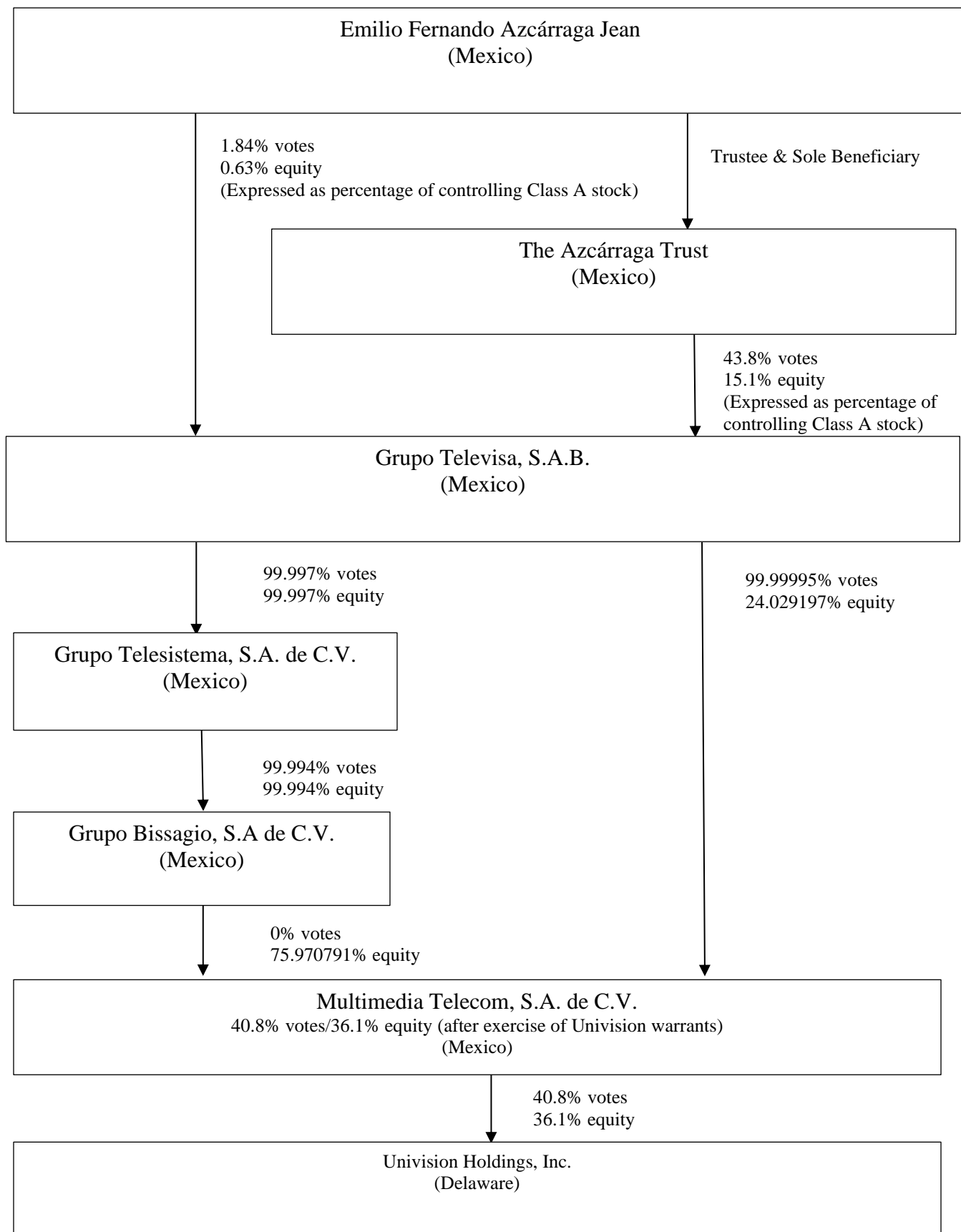

(ForgeLight Detail)

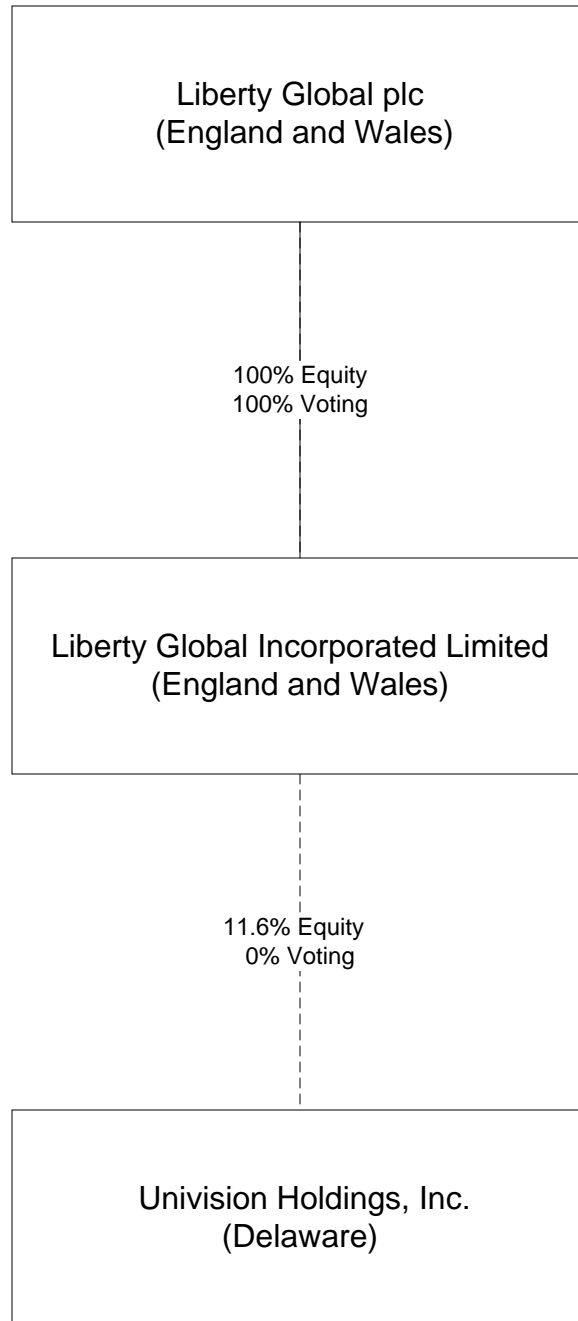




