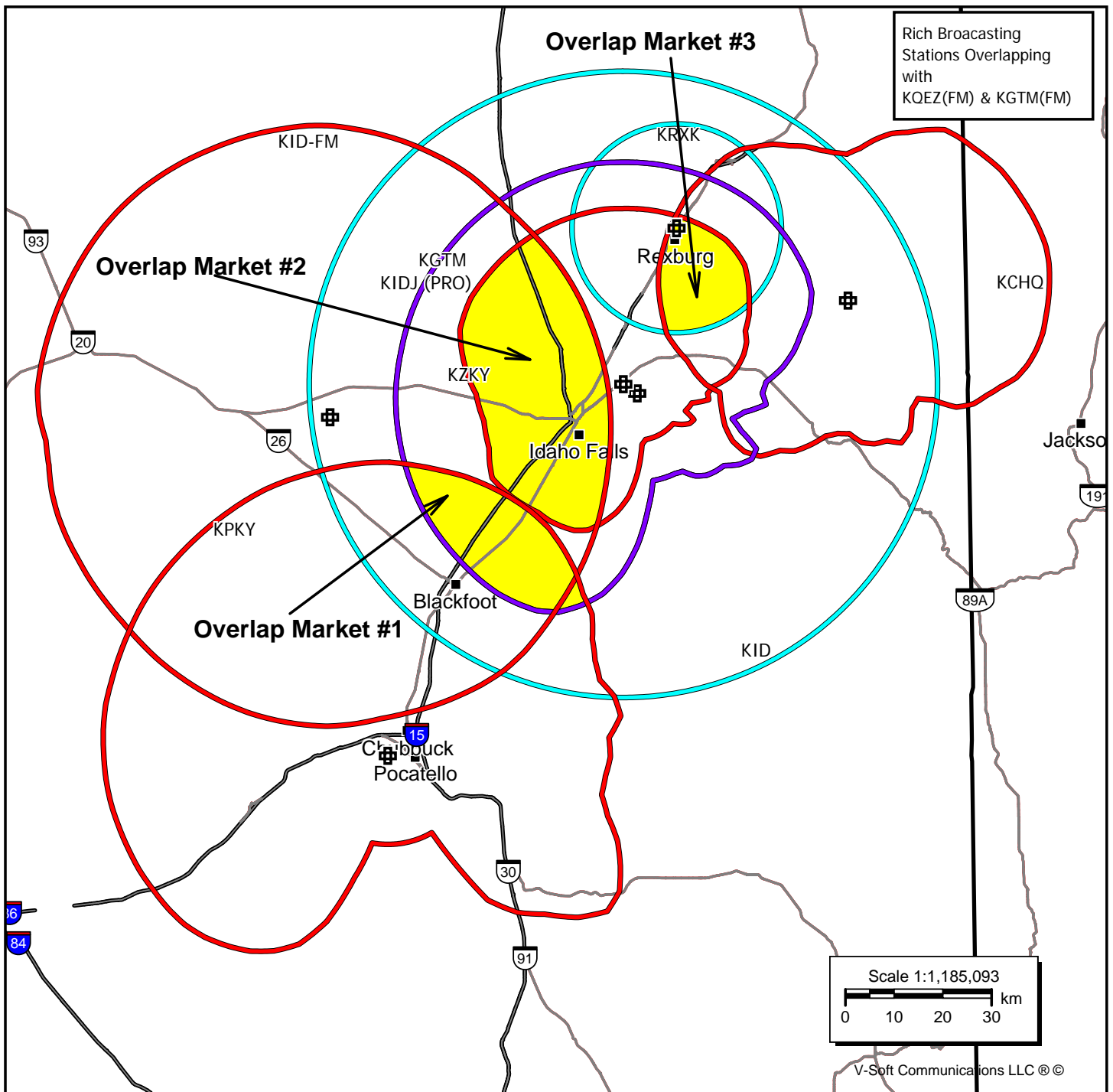

The current and proposed Communities of License for the station subject to this study are not located in a county which BIA and Arbitron define as being part of an Arbitron Metro nor have the stations appeared “above the line” in any Arbitron Ratings as reported by BIA in the previous two years. Therefore, the Modified Contour Overlap Method shall be employed to demonstrate multiple ownership compliance with Section 73.3555.

KIDJ(FM) proposes to modify its community of license at its presently licensed site. Even though no technical changes are proposed from its current license, in an abundance of caution, a Section 73.3555 multiple ownership study is hereby presented.

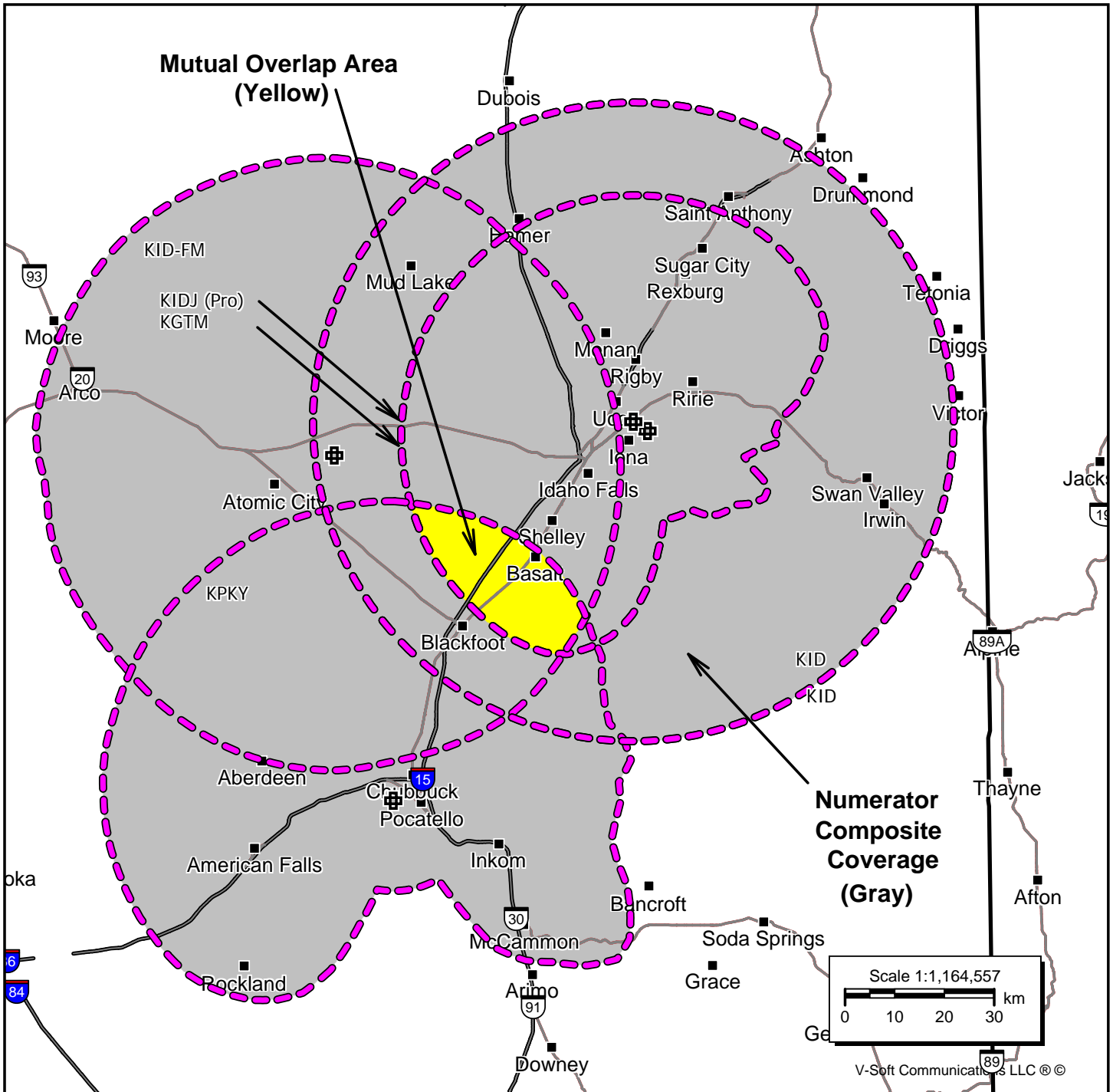

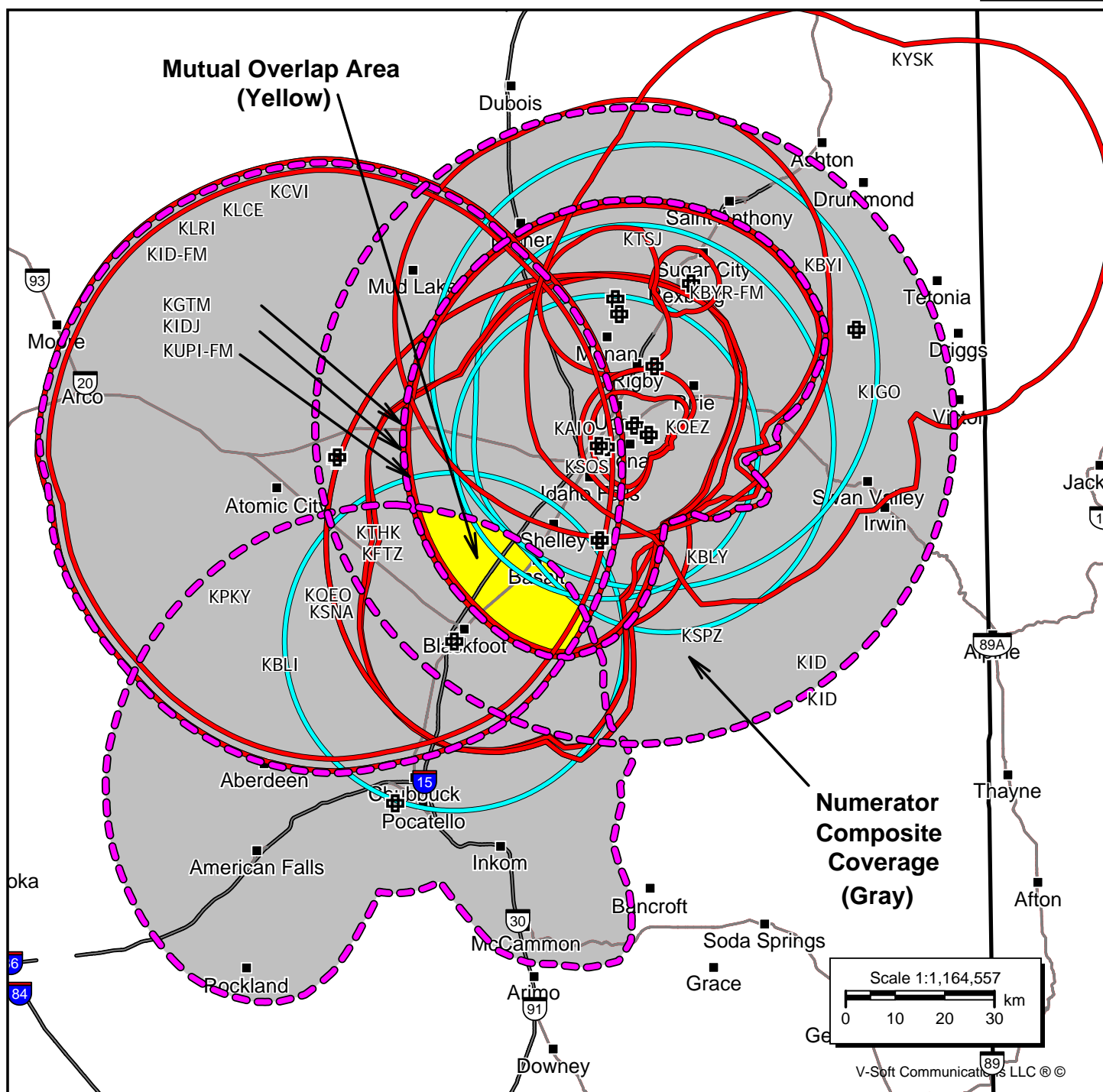

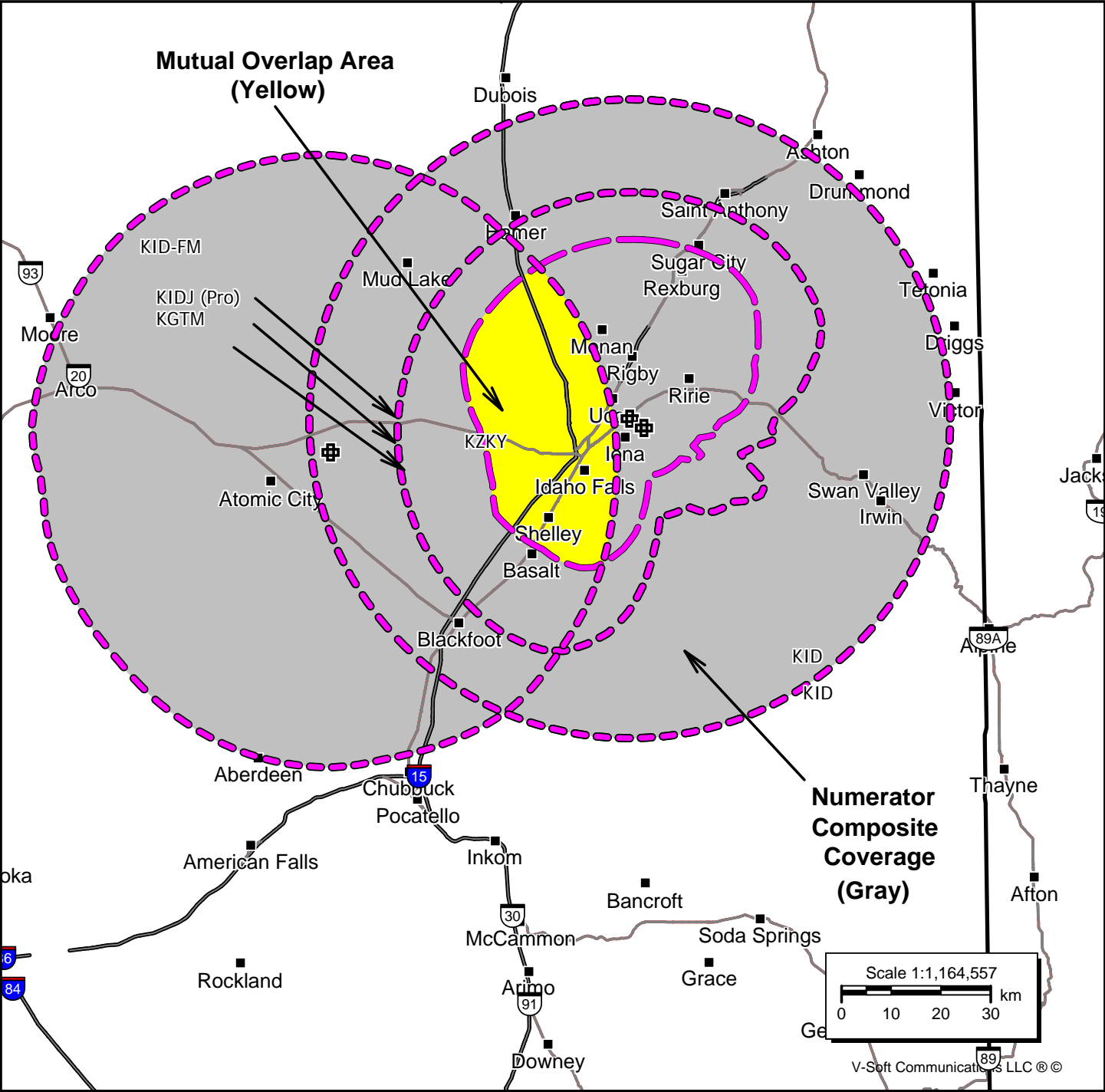

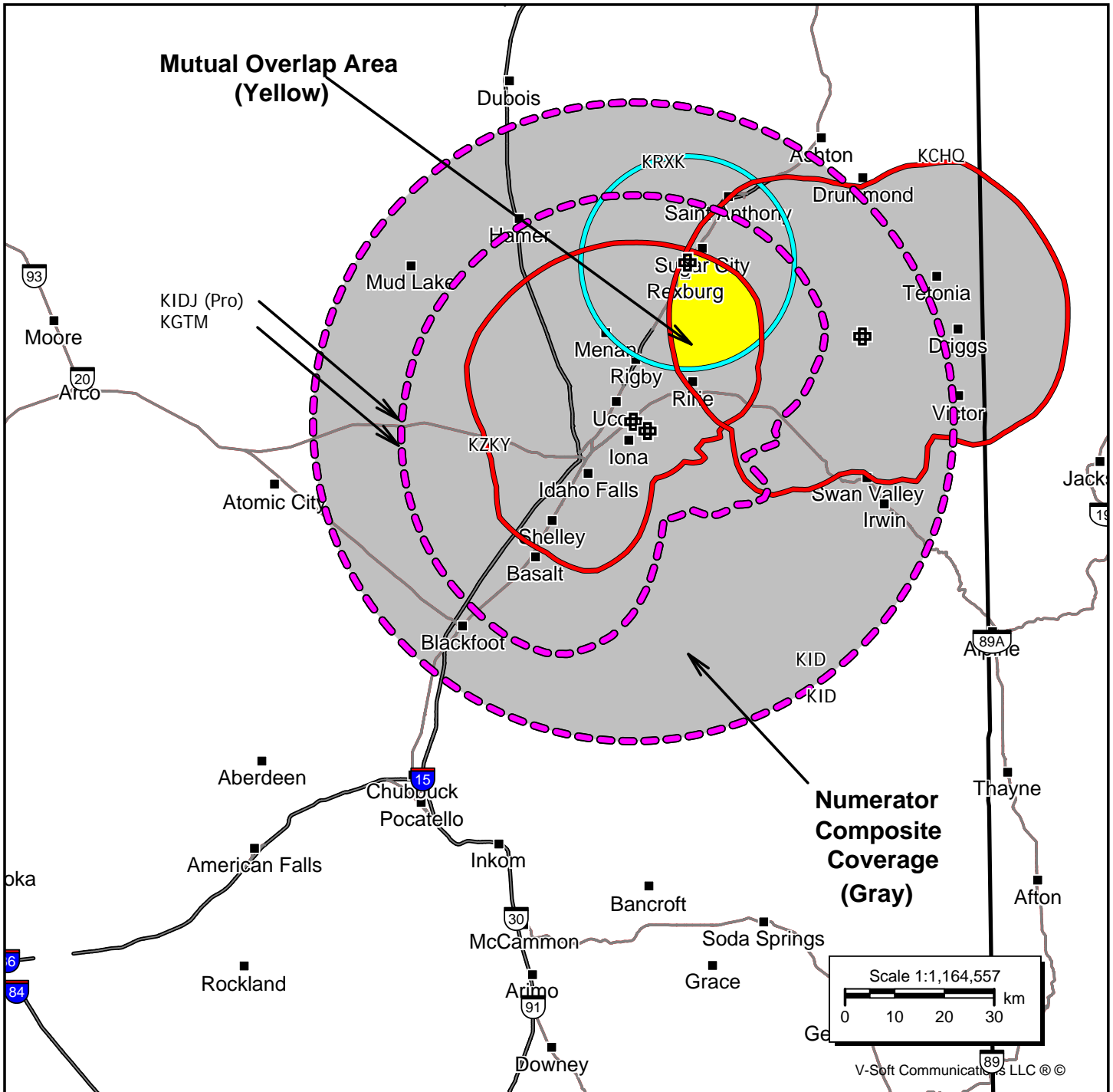
