TECHNICAL STATEMENT

This technical statement and attached exhibit were prepared on behalf of Cumulus Licensing LLC ("Cumulus"), licensee of FM translator station W278AA, Channel 278D, Madison, Alabama. Cumulus also holds an outstanding permit to make minor changes in the facilities of W278AA by changing to Channel 280D, and utilizing a directional antenna system.¹ Cumulus is requesting Special Temporary Authorization to use FM translator station W278AA, Channel 280D, Madison, Alabama to rebroadcast the programming of co-owned AM station WUMP, 730 kHz, Madison, Alabama.

WUMP is a Class D AM station authorized to operate on 730 kHz with a nominal power of 1.0 kilowatt day and 0.129 kilowatt night. During daytime hours, the WUMP 2.0 mV/m contour, which is required to demonstrate coverage of a community of 2,500 or more, encompasses 398,078 persons in 3,407.6 square kilometers. At night, due to the interference on the AM band from co-channel and adjacent channel stations, the effective coverage of WUMP is reduced to the 26.559 mV/m contour (nighttime interference free or NIF). The WUMP NIF

contour encompasses only 17,783 persons in 31.9 square kilometers, a substantial reduction of population from that within the daytime 2.0 mV/m contour. The contours of the facilities are shown on Exhibit #1.

Were W278AA used to re-transmit the programming of WUMP, a total of 123,123 persons in 350.1 square kilometers would receive service full time. It is also noted that the translator's 60 dBu contour is wholly encompassed within the 2.0 mV/m daytime contour of WUMP, as well as being within a 25.0 mile radius from the WUMP site.

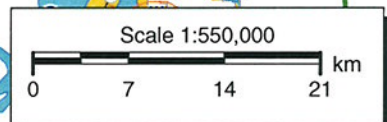




