Chatterbox, Inc., by its attorneys, hereby requests cancellation of the license for Station WYKC, Facility ID No. 10673, 1400 kHz, Grenada, Mississippi, as of this date and requests that its call letters be deleted. The licensee does not currently have a copy of the station license, as the building in which the license was housed was destroyed by fire. Further, since the license dates from before 1979, a copy is not available from the Commission's Consolidated Data Base System ("CDBS"), nor does CDBS have a date or file number for the license. Accordingly, a copy of the CDBS Station Search Details for the facility is enclosed for reference. The community of Grenada will continue to receive local transmission service from WQXB(FM), Facility ID No. 10672.
