Ownership Study

This ownership study is provided as an analysis of the aural broadcast market formed by the proposed upgrade of station WKLX at Brownsville, KY to C2.

WKLX is not located within an Nielsen Metro area; as a consequence, the permitted common ownership is determined using the contour overlap methodology. The attached exhibits include the city grade contours, 3.16 mV/m (70 dBu) (FM) and 5 mV/m (AM), of all stations intersecting any of the mutually overlapping stations, including noncommercial facilities, and excludes any stations with a transmitter site greater than 92 km from any portion of the mutually overlapping area, as well as any commonly owned stations which do not mutually overlap the defined markets. Exhibit A demonstrates that the mutually overlapping stations create two markets.






