

## **EXHIBIT 10**

Fresh Air, Inc. ("Fresh Air"), licensee of Noncommercial Educational Station KFAI (FM-NCE), Minneapolis, Minnesota, is a non-stock, non-profit organization. Fresh Air is filing this application to obtain Commission consent to new members of its Board of Directors.

The selection of Fresh Air's new Board of Directors took place pursuant to its Articles of Incorporation and By-Laws. The resulting transfer of control occurred gradually, over time, through routine changes in board membership. The board elections held in the years since the FCC last had the opportunity to approve the Board demonstrate the gradual nature of the change in control. The Board Members during each of those years are set forth in the chart on the following page. The chart reflects the board members as they existed following the annual business meeting each year.

This application is intended to bring the station into compliance with the requirement to obtain FCC approval of the board after 50% of the members of the board of directors have changed. The FCC last approved the board of Fresh Air in December, 2004 in FCC File No. BTCED - 20041124AFV.

No consideration or thing of value is being given in exchange for the interests being transferred. All Board Members are U.S. citizens. Each Board Member has one vote. None have any interests in any mass media other than KFAI.
