**Description:** EXPLANATION

ON OCTOBER 24, 2008, THE KQBA TOWER SITE WAS VANDALIZED BY A COPPER THIEF OR THIEVES AND THE STATION IS SILENT AS A RESULT. APPROXIMATELY 40 TO 50 FEET OF 4 INCH COPPER TRANSMISSION LINE WAS STOLEN ALONG WITH SIGNIFICANT COPPER ELECTRICAL CIRCUITRY. RELATED PHYSICAL STRUCTURE AND EQUIPMENT WERE DAMAGED IN THE COMMISSION OF THE THEFT.

STATION ANTICIPATES REMAINING SILENT ROUGHLY 30-90 DAYS IN ORDER TO ASSESS THE DAMAGE, OBTAIN COST ESTIMATES FOR REPAIR WORK, THEN SCHEDULE AND EFFECT REPAIRS.

THE BASIS FOR GOING SILENT IS BEYOND THE STATION'S CONTROL.
