

Purpose of Application and Use of Form 316

Bridgelight, LLC, licensee of non-commercial educational radio stations WJUX(FM) and WRDR(FM), is a single member limited liability company. The sole member of Bridgelight, LLC is Calvary Chapel of Old Bridge ("CCOB"), a non-profit, non-stock religious corporation organized under the laws of the State of New Jersey and controlled by its Board of Trustees.¹ The Board of Trustees of CCOB currently consists of six members, each of whom has one vote. The purpose of this application is to request consent to transfer of control to the current Board of Trustees, as listed on Page 2 of this exhibit.

As is typical of non-profit, non-commercial educational licensees, the composition of the Board has gradually changed over the years. The table at pages 3-5 of this Exhibit demonstrates that the changes in the composition of the Board have occurred gradually since the Commission last granted an application approving a previous Board in 2005. (*See* BTCED-20051202ABB, granted December 13, 2005). Accordingly, use of Form 316 is appropriate for this application.

No written agreements exist documenting the changes herein listed, as they occurred through the ordinary processes of attrition and appointment of new Trustees. All Trustees are U.S. citizens. Addresses for current Trustees are provided on Page 2 of this exhibit.
