We are currently processing your above-referenced application. Our preliminary engineering review shows that the application requires tower registration with the FAA.

The proposed facility shows the overall tower height above ground level at 7 meters and the site elevation above main sea level at 2395 meters for the coordinates of N 39-15-53.1 - W 114 53 35.1

Our tower determine search results, as imported below, using the specifications of the proposed construction permit as indicated above shows that the tower failed slope:
