

**LOTUS COMMUNICATIONS CORP. & AFFILIATES**

**STRUCTURE**

**A.**

**OVERVIEW**

Lotus Communications Corp. (Lotus Corp.), a California corporation, is a holding and operating company, with headquarters at 3301 Barham Boulevard 90068, Los Angeles, California. Lotus Corp. and its affiliates (collectively, the “Company”) own and operate (i) twenty-four radio stations, with an AM station on 1100 kHz under construction in Las Vegas, Nevada, (ii) three FM translator stations and (iii) three Low Power Television stations. The radio stations are in Arizona, California, Nevada and Texas, the television stations are in Arizona, Florida and Texas.

Lotus Corp. is controlled by Howard A. Kalmenson of Los Angeles, California, who votes all the outstanding, voting shares in Lotus Corp. and votes all equity interests held by Lotus Corp. in its affiliates. Stated otherwise, Howard A. Kalmenson exclusively controls the Company.

Lotus Corp. stock is composed of Class A common and voting, and Class B common and non-voting. There are 500 issued and outstanding shares of Class A stock. These shares are owned, in equal parts, by The Howard A. Kalmenson Trust (Howard A. Kalmenson Trustee) and The Lilli Kalmenson Rosenbloom Trust (Lilli Kalmenson Rosenbloom, Trustee). The Class B non-voting common stock - shares are issued and outstanding - are held by Diane K. Levine of Ryebrook, New York, in her individual capacity (eighty shares), and as Executor of the Estate of Burton Levine (five shares). The stockholders and trustees are U.S. citizens, and U.S. entities.

**NON-CORPORATE RADIO AFFILIATE**

Lotus Corp. has a single, non-corporate radio affiliate, Lotus Texas Ltd. which is a Texas limited partnership, composed of Texas Lotus Management Corp., a Nevada corporation (general partner), and Texas Lotus Investments, a Nevada limited liability company (limited partner). The former and latter entities respectively own 1% and 99% of the equity in Texas Lotus, Ltd. and are wholly-owned by Lotus Broadcasting Corp. which, as noted above, is a first-tier corporate subsidiary of Lotus Corp.

**C.**

**COMPANY TELEVISION INTERESTS**

The Company's television station holdings are set out in Part IV hereof. The Company's television licensees consist of an Arizona and a Florida limited liability company and a Texas limited partnership. The Arizona limited liability company is Lotus TV of Phoenix LLC, licensee of Station KPHE-LP, Phoenix, Arizona; the Florida limited liability company is Lotus TV of Tampa LLC, licensee of Station WTAM-LP, Tampa, Florida. The Texas limited partnership is Lotus TV of Houston Ltd, which consists of Texas Lotus TV Management, a Texas limited liability company (general partner), and Texas Lotus Investment No. 2 LLC, a Nevada limited liability company (limited partner). The former and latter entities respectively own 1% and 99% of the equity in Lotus TV of Houston Ltd., each of these entities is owned directly by Lotus Corp.
