Section 1.2112(a): FSI is a non-profit corporation with three directors: Thomas Evans, Allen W. Sill, Jr. and William Thomas Rainey III, who were listed as Disclosable Interest Holders in FSI's amended Auction 100 Form 175, submitted on May 21, 2019 (File Number 0008080674). Each of the three holds one vote on the FSI board. Mr. Evans continues to be FSI's President. Mr. Sill is the corporation's Secretary. Mr. Rainey is its Treasurer. Mr. Evans and Mr. Sill, who were listed in the Form 175 initially, together still hold a majority of the voting interest in FSI. A complete list of FSI's broadcast interests are listed below as ***Attachment A***.
