# AMENDMENTS

TO THE BYLAWS OF  
GREAT PLAINS CHRISTIAN RADIO, INC.

AMENDMENT DATE: MAY 24, 2001

## ARTICLE \_\_\_\_\_

*If GPCR is granted a preference based upon diversity of ownership in any Noncommercial Educational comparative context and receives one or more authorizations from the Federal Communications Commission as a result of such claim(s), GPCR shall not, for a period of at least four years after the date upon which it commences broadcast operations pursuant to said authorization, purchase, acquire, apply for or construct any other broadcast station(s) whose principal community (city grade) contour would overlap with the principal community contour of such FM broadcast station as that previously described.*

## ARTICLE \_\_\_\_\_

*No person who serves on the GPCR Board of Directors nor any officer of GPCR shall, at any time while serving on the Board of Directors or as an officer, concurrently serve as an officer or director, or have any other attributable ownership or other interest in any other broadcast station whose principal community (city grade) contour overlaps with the principal community contour of any FM broadcast station for which GPCR obtains an authorization as a result of a preference based upon diversity of ownership in any noncommercial comparative context. All GPCR officers and board members shall observe this restriction with respect to any station authorized as a result of a diversity preference for a period of at least four years after the date upon which said station commences broadcast operations.*
