TECHNICAL STATEMENT

1. This technical statement and attached exhibits were prepared on behalf of Miller Communications, Inc. ("Miller"), licensee of radio stations WWKT-FM and WDKD (AM) Kingstree, South Carolina; WICI FM and WDXY (AM), Sumter, South Carolina; WIBZ, Wedgefield, South Carolina; and WKHT, Bishopville¹, South Carolina. Miller has proposed changes to each of the associated FM stations which, in some cases, has an effect on the radio market(s) as they are defined by the Federal Communications Commission.

PRESENT LICENSES

2. As demonstrated in Exhibit #1, there are contour overlap issues which exist between the above noted licensed stations. These contour overlaps comply under the provisions of §73.3555 (a)(1)(iii) for co-ownership of up to six broadcast entities, four of which may be in the same broadcast service. This results in Radio Market #1 consisting of FM stations WWKT-FM, WIBZ, WICI, WKHT and AM WDXY, while a second market consists of FM station WWKT-FM and AM station WDKD, as allowed under §73.3555(a)(2).

1) WKHT has been ordered to change community of license to Lamar, South Carolina.

PENDING APPLICATIONS

3. Each of the FM stations involved in this multiple ownership group have pending applications for facility modifications. The definition of the radio markets is primarily affected by the relocation of WWKT-FM, as proposed.² Exhibit #2 is a depiction of the co-owned stations and market definitions considering only the proposed FM changes and the unchanged AM facilities. We note that WWKT-FM (proposed) is a contributor to each of the markets.

4. To simplify compliance with the multiple ownership provisions of §73.3555, we have considered only the proposed WWKT-FM relocation as a most conservative market boundary. To determine compliance, this study examines the number of stations providing city grade service to the WWKT-FM proposed city grade contour or stations who have sites within the city grade contour of this subject station. The city grade contour of this subject station is shown on Exhibit #3. This contour establishes the market boundary, hereinafter referred to as "Radio Market".

5. Exhibit #4 is a map showing the contributing stations while Exhibit #5 is a tabulation of the stations depicted on Exhibit #4. As Exhibits #4 and #5 show, there are fifteen stations (excluding the subject stations) in the Radio Market. Therefore, the ownership of WWKT-FM, WIBZ, WICI, WKHT and WDXY in one market³; WWKT-FM, WKHT and WICI in a second market⁴; and WWKT-FM and WDKD in a third market⁵ is in compliance with the Commission's

2) WKHT (from Bishopville to Lamar) also affects the radio market boundaries.

3) WIBZ (licensed or proposed), WICI (licensed or proposed), WWKT-FM (proposed) and WDXY (licensed).

4) WICI (proposed), WKHT (proposed) and WWKT-FM (proposed).

5) WDKD (licensed) and WWKT-FM (proposed).



multiple ownership rules. As such, the proposed minor change for WWKT-FM is in compliance with the Commission's rules.




