**Complaint of Interference by FM Translator Station to Full-
Service Station**

Dear Ms. Dortch:

We are counsel to Gow Media, LLC ("Gow"). Gow is the licensee of full-service FM Station KFNC(FM) (97.5 MHz), Mont Belvieu, Texas (FIN: 52407).

Gow is hereby filing this Complaint against FM Translator Station K247CP, Houston, Texas (the "Translator Station" or K247CP), which is licensed to Elohim Group Corporation ("Elohim") and operates, on a first adjacent channel basis, on Output Channel 247 (97.3 MHz).

This Complaint arises from what Gow submits is a clear and uncontested violation of Section 74.1203(a)(3) of the Commission's Rules.¹ Section 74.1203(a) mandates that an FM translator "will not be permitted to continue to operate if it causes any actual interference to: (3) The direct reception by the public of the off-the-air signals of any full-service station...." KFNC has, since the recent resumption of operations of the Translator Station, been the recipient of actual interference from K247CP and has no recourse but to bring its concerns to the Commission's attention, once again, for prompt resolution and remediation as required by the Interference Order.

¹ Section 74.1203(a)(3) was recently amended in *Amendment of Part 74 of the Commission's Rules Regarding FM Translator Interference*. 34 FCC Rcd 3457 (2019) (the "Interference Order") and is in accord with the rule modifications contained therein.

Gow has been monitoring the impact of the Translator Station operating on a first adjacent channel to KFNC since 2017, when Elohim's predecessor filed its application, in File No. BPFT-20170206ACJ, for a construction permit to operate on Output Channel 247. The interference to KFNC was predicted to be such that the application was dismissed in *Letter to Centro Cristiana De Vida Eterna* (released March 28, 2017).

The licensee tried once again, shortly thereafter, in File No. BPFT-20170608ABA, to operate on Channel 247. As detailed by the Commission, in *Letter to Barry A. Friedman, Esq.*, Ref No. 1800B3-CEG (released May 7, 2018), this attempt was dismissed as well. In that letter decision, the Commission concluded that the application filed by the then licensee of K247CP violated Commission rules on the following basis:

Here, Gow has followed this protocol by submitting documentation from listeners certifying that they are regular listeners of KFNC, either at home or at work, and plotting the specific addresses on a map depicting the Translator's proposed 60 dBu contour at the Missouri City Site. Gow has also demonstrated that grant of the June 2017 Modification Application would result in interference to those listeners. Therefore, we will dismiss the June 2017 Modification Application under Section 74.1204(f). (footnotes omitted).

Since then the Translator Station has been primarily off-air, though the periods of silence are not regulatory recorded and evidenced in the FCC's database. Likewise, the Translator Station has sought to modify its license, in File Nos. BPFT-20190102AIZ and BMPFT-20190424ABG, and, in both instances, the application has either been dismissed and or the permit cancelled. In connection with these applications, the Commission's record includes a full-service broadcaster's written statement challenging the Translator Station licensee's claim that the Translator Station was authorized to rebroadcast its signal. All of this evidences a translator broadcaster that has established a record of playing fast and loose with Commission rules, other stations' intellectual property rights, and s continually operating in a reckless manner by causing impermissible interference to the operations of adjacent full-service broadcasters. It would be one thing if this was the first instance, but this is the continuation of a long record of causing interference and continuing to do so despite being told by the Commission that it could not do so.

For whatever its reasons, Elohim has now decided, despite its record of causing interference, to resume operations. As described in the attached Declaration of David Gow (Attachment A), the President of Gow, **Gow has in recent weeks sought out and met with Elohim and individuals associated with Elohim in order to resolve the interference issues. Despite Gow's best efforts, Gow has been unable to secure the cooperation of Elohim and its associated parties in reaching any acceptable resolution that would result in an elimination of the**

impermissible interference. Gow is required, once again, to spend time, effort, and funds to protect itself from the level of interference that Elohim knows, from past history, it will cause.

In that FM translator stations are secondary services, they have no absolute right to continue to broadcast under any circumstances. Section 74.1203(a) and the Interference Order teaches us that FM translator stations must protect full-service stations. *The Association for Community Education, Inc.*, 19 FCC Rcd 12682 (2004). When it is evidenced, by listener communications or otherwise, that an FM translator is interfering with a full-service radio station, the FM translator licensee must shut down its operations or the Commission will shut down the FM translator in order to protect the full-service station, as provided for in Sections 74.1203(e) and 74.1232(h). *Id.* at 12688.

Attached hereto, as Supplement A, are the Listener Complaints in support of this submission and an Engineering Statement of Gow's consulting engineer. In compliance with Section 74.1201(k), there are **30 Listener Complaints**, in excess of the 25 Listener Complaints, as required by Table 1 to Section 74.1203(a)(3), evidencing that a substantial number of KFNC listeners have been detrimentally affected by the interference being suffered, together with an Engineering Statement showing that the Listener Complaints meet the location requirements contained in Section 74.1203(a)(3). The Listener Complaints include the following information:

- **The full name, complete address and telephone number of each Listener complainant.**
- **A clear, concise and accurate description of the exact location where the Listener complainant has suffered the interference claimed.**
- **The signature of the Listener complainant dated within one year of this date.**

The Engineering Statement confirms that **KFNC is operating within its licensed operating parameters** and shows the required **undesired/desired data that demonstrates the interference, calculated using the Commission's contour prediction methodology, is in excess of the level that evidences impermissible interference to KFNC.** The impact of the interference is harm to KFNC that cannot be easily or quickly resolved and gets worse by the day, requiring prompt action on the Commission's part.


Considering these factors, Gow requests that the Commission act, as provided for in Section 74.1203(b), by suspending the operations of Station K247CP "until the interference has been eliminated." Further, given the history of interference in connection with the Translator Station and the number of instances in which Gow has had to protect its Station from interference

through objections and complaints to the Commission, Gow requests that the Commission require that Station K247CP not resume operations until and unless it has a new construction permit, to operate from a different and non-interfering transmitter site, and Gow has been given an opportunity to object to such request for modification of license for Station K247CP. DECLARATION OF DAVID GOW

I, David Gow, do hereby declare as follows:

1. I am the President of Gow Media, LLC, the licensee of Station KFNC(FM), Mont Belvieu, Texas (FCC FIN: 52407)
2. In connection with the submission of a Complaint dealing with the interference that has affected the listeners of KFNC, I have made several attempts to convince Elohim Group Corporation ("Elohim"), the licensee of Station K247CP, Houston, Texas, and parties associated with Elohim of the interference to KFNC and have been unable to secure any cooperation in the resolution of KFNC's interference concerns.

I declare under penalty of perjury that the foregoing is true and correct, to the best of my information, knowledge and belief.

SUPPLEMENT A

ENGINEERING STATEMENT

This Engineering Statement has been prepared on behalf of Gow Media, LLC, the licensee of FM radio station KFNC, Mont Belvieu, Texas, and in support of an interference complaint against FM translator station K247CP, 247D, Houston, Texas, licensed to Elohim Group Corporation (“Elohim”). K247CP, which broadcasts on the first adjacent channel to KFNC, has been and is continuing to generate significant and impermissible interference to KFNC well within the protected KFNC 45dBu f50,50 contour. KFNC’s main transmitter is and has been operating at full power at the licensed main site continuously pursuant to its licensed parameters and **KFNC was operating within its licensed parameters on the dates of each of the Listener Complaints considered in this Engineering Statement.**

KFNC is licensed to operate on Channel 248C (97.5MHz) with 100kW effective radiated power (“ERP”) and at 597 meters Height Above Average Terrain (“HAAT”). KFNC broadcasts from a 2,000-ft. tower located near Winnie, Texas and provides documented service to areas and population within its 45dBu FCC f50,50 contour.

This Engineering Statement will demonstrate that the interference to KFNC from K247CP meets the new interference protection guidelines adopted by the Report and Order in MB Docket Number 18-119 (FCC 19-40), released May 9, 2019. KFNC has readily obtained over 40 Listener Complaints in a short period of time and is **submitting 30 Listener Complaints with this Statement, which number exceeds the listener complaint requirement** contained in Section 74.1203(a)(3) for a Station with the protected contour such as that of KFNC.¹ These documented KFNC Listener Complaints represent only a small fraction of the listeners that KFNC serves in the Houston area who are equally adversely affected by the translator’s impermissible and harmful interference.

¹ 25 Listener Complaints is the upper limit of Listener Complaints required for any broadcast station under Table 1 to Section 74.1203 of the Commission’s Rules.

HARMFUL INTERFERENCE

K247CP broadcasts on the first adjacent channel to KFNC. The K247CP transmitter site is located just inside the 51dBu contour for KFNC. As is reflected in the supporting materials, many of the interference complaints involve locations inside the 70dBu contour of K247CP. At these locations, K247CP generates more than 25dB in excess of the allowable undesired/desired signal ratio to KFNC, **which is well in excess of the -6 dB U/D threshold ratio for first-adjacent channel interference listener complaints**, Exhibit D is a map denoting each location where a listener complainant has experienced interference from K247CP and the applicable undesired/directed ratio at each site.

Exhibit A is a chart describing the interference types and locations. The following information is gleaned from this chart:

- There are 30 separate respondents used in this evaluation. Interference was received either at specific home, work, or commuting locations.
- There are 38 separate and valid (inside the KFNC 45dBu contour), fixed location complaints (home and/or work).
- There are 18 separate complaints of mobile interference as shown on the map contained in Exhibit C. All these complaints represent specific locations along drive routes from home to work. Many follow the same direction along I-10 (yellow route) which runs directly next to the K247CP transmitter. U/D ratios for specific mobile reception locations are shown in Exhibit F.
- There are several complaints of workplace interference from the vicinity of 1334 to 1384 Brittmore Rd. This location is one of the largest shared (co-working) workplaces in the nation and is located adjacent to the K247CP transmitter. All the complaints arising from this location are associated with commuting interference complaints and each of these complaints are to/from a unique home address.

Exhibit B specifies the referenced points correlated to the addresses shown in Exhibit A and the Undesired to Desired interference levels based upon FCC 50/50 and 50/10 contours at each point. These points are also illustrated on the map in Exhibit D.

AUTOMOBILE INTERFERENCE

The K247CP transmitter site is located directly adjacent to Interstate 10 and near the Sam Houston Tollway (SL 8). As shown in Exhibit B, multiple interference complaints specify commuting interference to KFNC from K247CP along some of the most congested driving routes in the Houston area, especially along I-10 and consisting of an area roughly bounded by Hwy 280 to the North, Montrose Road in central Houston to the East, the Westpark Tollway to the South, and Beltway Hwy 6 to the West. U/D ratios at reference mobile locations are shown in Figure F. As documented in Exhibit E, there are 297,000 daily commuters along the 18km stretch of Interstate I-10 between Interstate 610 and the SL8 tollway. Many of these commuters pass directly next to the K247CP antenna and are exposed to extremely strong signal levels from K247CP. All of the above-referenced routes are inside the 45dBu contour of KFNC.

CONCLUSION

KFNC has a long history of being forced into playing “whack-a-mole” with K247CP. Gow has had to repeatedly file against Elohim’s (and its predecessor’s) applications or operating facilities over the last several years. Based upon the new interference protection standards, it is unquestionable that Elohim continues to violate the requirement that it protect all full power FM stations from impermissible interference within KFNC’s 45 dB contour.

Because of the continued egregious interference which is causing ongoing harm to the KFNC listeners, Gow respectfully requests that the Commission order the operations of K247CP suspended and not permit K24CP to resume operations from its currently licensed or other location until it can be proven that such operation of the translator station will not cause any interference to KFNC within the protected KFNC 45dBu contour.

***NOTE:** The Brittmore Road location is a site of significant listenership of KFNC. This is because that site is the location of a large incubator/co-working space. The multiple enterprises operating at that location employ a large number of young, primarily male, individuals, many of whom are avid listeners of sports and sports/talk radio in general, and KFNC in particular.

NOTE- Color Keys refer to drive routes used by a number of respondents noted in Exhibit C. Note that most of these drive routes are in the direct vicinity of the K247CP transmitter and many respondents have indicated that their drive route takes them to the vicinity of I-10 which is within 0.1km of the K247CP transmitter.

EXHIBIT C- Drive Route Map

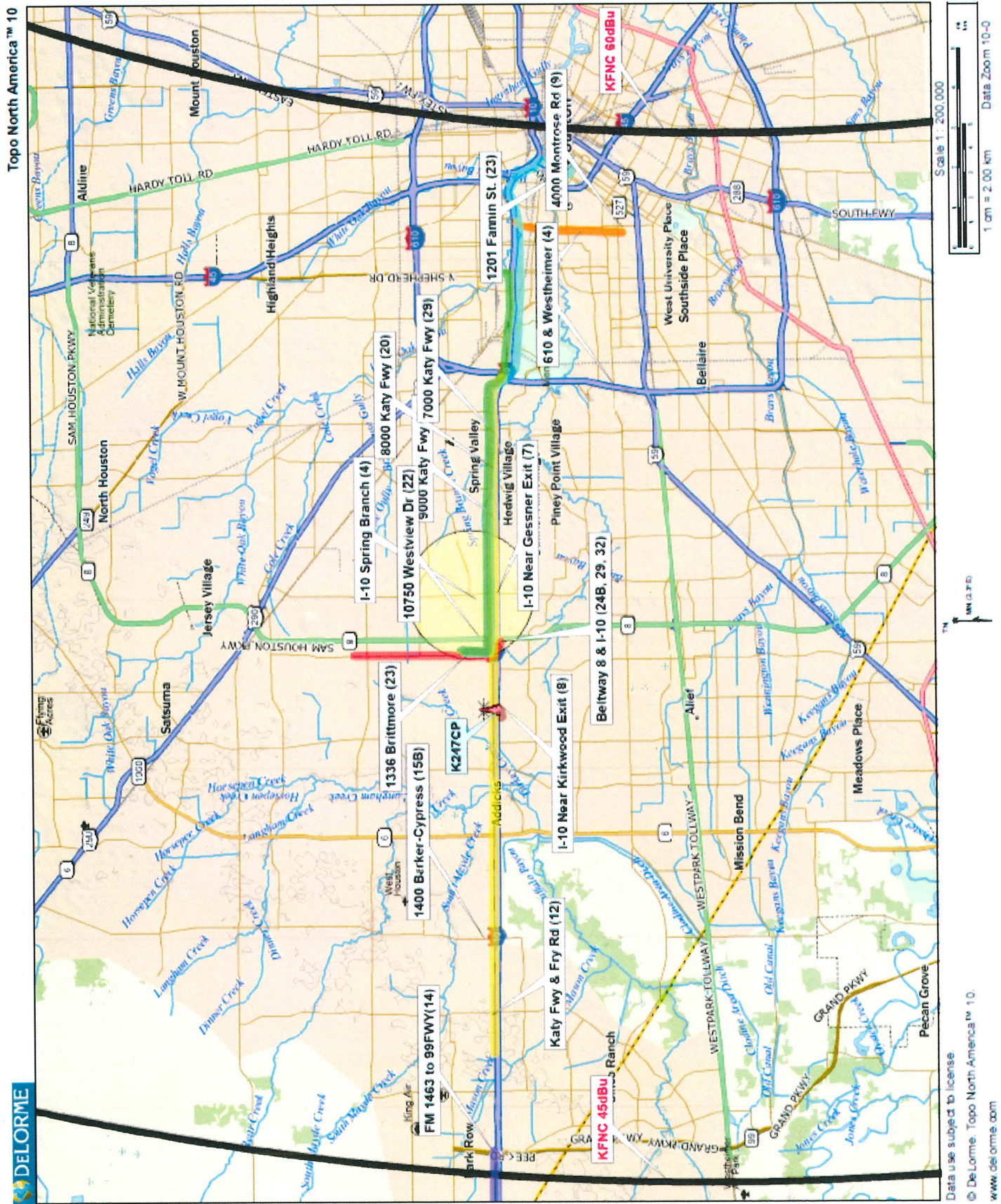


EXHIBIT D- Fixed Interference Location Map

KFNC Interference Complaints from K247CP

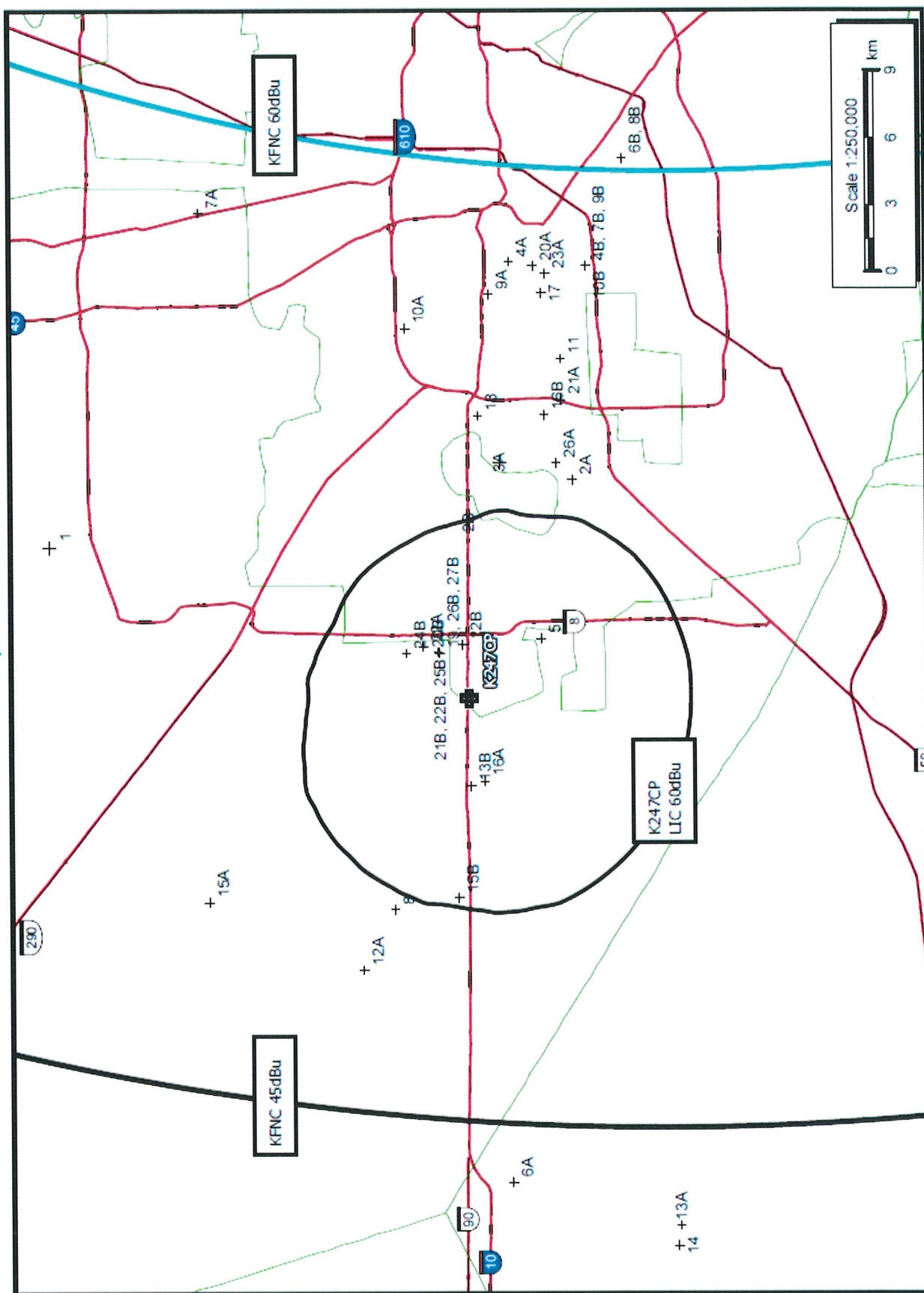


EXHIBIT E- I-10 Excerpt from Congestion Report

Current Conditions

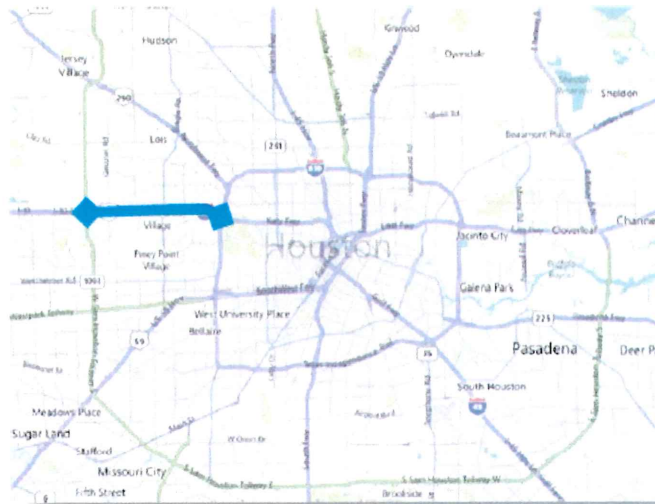
From IH 610 North to Beltway 8 (Sam Houston Tollway), IH 10 is an east-west freeway with five to six general purpose lanes and three to four lanes of continuous frontage roads in each direction. Four managed lanes (two each direction), known as the Katy Tollway, operate in the middle of the corridor. During peak hours, high occupancy vehicles (HOV) may utilize the Katy Tollway for free, while single occupancy vehicles (SOV) must pay a dynamically-priced toll rate which varies throughout the day based on traffic volume. During off-peak hours, the tollway is dynamically-priced for all vehicles regardless of occupancy. METRO and school buses are allowed to utilize the managed lanes at all times toll-free.

Traffic on IH 10 loosely follows a traditional inbound/morning and outbound/evening congestion pattern, though both directions experience significant slowdowns during the evening peak period.

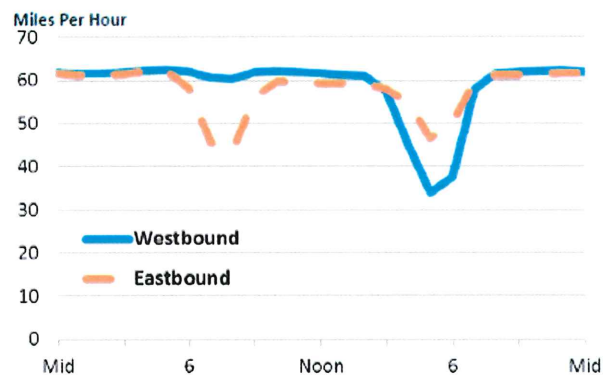
