¹ The Commission has suspended the proposed elimination of the “single majority shareholder” policies. *See Order*, FCC 01-353, ¶1 (December 14, 2001). As a consequence of the voting authority held by Joseph M. Field, minority stock ownership interests in Entercom generally do not represent attributable interests under the Commission’s ownership rules and policies. However, Entercom is providing the percentage of votes for officers and directors of Entercom as of March 1, 2005.

² With respect to item 4, certain of the officers and directors of Entercom hold options to acquire stock in Entercom under Entercom’s Equity Compensation Plan and/or the Employee Stock Purchase Plan. With respect to item 5, there is no person or entity that holds 33% of the total assets (debt plus equity) of Entercom, as set forth in Section 73.3555 Note 2(j) of the Commission’s rules.

³ The stock information represents voting power of shares beneficially owned of all classes of Entercom stock, as disclosed in the Proxy Statement dated May 6, 2005 of Entercom pursuant to the Securities Exchange Act of 1934.
