Request for Extension of Special Temporary Authority

Dear Ms. Dortch:

This letter is prepared on behalf of The University of Tulsa, licensee of stations KWGS(FM), Tulsa, Oklahoma operating on Channel 208C1 with 50 kW at an HAAT of 325 meters and KWTU(FM), Tulsa, Oklahoma, Channel 204C2 with 5 kW at an HAAT of 325 meters.

Stations KWGS(FM) and KWTU(FM) operate from a common antenna. This antenna received damage due to severe weather and while KWTU(FM) has been restored to full-power KWGS(FM) remains operating at 50% of ERP.

The University of Tulsa filed a request for Special Temporary Authority ("STA") with the Federal Communications Commission ("FCC"). The FCC granted a special temporary authority for station KWGS(FM) to operate pursuant to Section 73.1560(d) until June 17, 2010. The KWGS(FM) technical staff advises that a new eight-bay antenna has been ordered from Dielectric, but have yet to receive delivery.

Therefore, an extension of the Special Temporary Authority is hereby requested for a period of an additional 90 days for FM station KWGS(FM) beyond June 17, 2010.
