

**ATTACHMENT TO EXHIBIT 2**

New Hampshire Public Radio, Incorporated (“NHPR”) is the licensee of the following non-commercial educational FM broadcast stations:

WEVO(FM), Concord, NH  
WEVH(FM), Hanover, NH  
WEVN(FM), Keene, NH  
WEVC(FM), Gorham, NH  
WEVJ(FM), Jackson, NH  
WEVS(FM), Nashua, NH  
WEVQ(FM), Littleton, NH, and  
WEVF(FM), Colebrook, NH

In addition, NHPR is the licensee of various FM translator stations.

NHPR is a non-stock non-profit organization. NHPR is filing this application to obtain Commission consent to new members of its Board of Directors.

The selection of NHPR’s new Board of Directors took place pursuant to its organizational documents, including its Articles of Agreement and its By-Laws (as amended). The resulting transfer of control occurred gradually, over time, through routine changes in board membership.

This application is intended to bring the station into compliance with the requirement to obtain FCC approval of the board of directors after 50% of the members of the board of directors have changed. The board members during each of the years from December 31, 2007, when the Commission last granted a Form 316 application (BTCED-20071221ACI *et. al*) for transfer of control of NHPR, to the present, are set forth in the chart below.

No consideration or thing of value is being given in exchange for the interests being transferred. All board members are US citizens. Each board member has one vote. None has any interest in any medium of mass communications other than the stations licensed to NHPR.
