1. Pursuant to Section 1.2107(d) of the Commission's Rules, Victor Vickers certifies that he is not now, nor has he been at any time, a party to any bidding consortium, joint venture, partnership, or other agreement or arrangement relating to the competitive bidding process for FM Auction 94.
2. The certification requirements under section 1.2110(i) of the Commission's Rules regarding designated entities are not applicable to Victor Vickers.
3. Pursuant to Section 1.2112(a) of the Commission's Rules, Victor Vickers hereby certifies that he is disclosing below or has disclosed elsewhere in this application:
 - a) that Victor Vickers as sole proprietor will have complete ownership and control over the station.
 - b) No other individual or entity will hold any ownership or control of the station.
 - c) Victor Vickers was the successful bidder for two construction permits in FM auction 94, giving him the right to file a long form applications for new FM station in Homerville, Georgia (MM-FM992-A) and Americus, Georgia (MM-FM892-A). Such applications are being filed before the filing deadline of July 24, 2013 set by FCC Public Notice DA 13-1080. Other Media interests of Victor Vickers are listed in Exhibits 3 and 5 of this application.
4. Section 1.2112(b) of the Commission's Rules, regarding small business status is not applicable to Victor Vickers.
5. Bidding Credit: Victor Vickers received a 25% bidding credit in conjunction with his participation in FM Auction 94.

Pursuant to Public Notice DA 13-1080, released May 14, 2013 at ¶¶ 25-26, Victor Vickers is providing this exhibit demonstrating his eligibility for the asserted bidding credit. Prior to and during the auction Victor Vickers as an individual applicant and sole proprietor holds complete ownership and control of the applicant.

Based on the required assessment performed as of the date of filing of the short form application, Mr. Vickers through a 33.3% interest in the licensee of NCE FM station WKIH (FM) holds an interest in only one other station defined as a media of mass communications.¹ This assessment took into account the concepts of spousal and familial attribution, as well as any possible interests held by

substantial investors or creditors. Accordingly, in his form 175, Victor Vickers properly asserted his entitlement to a 25% Bidding Credit. Since the close of the auction, no change has occurred that would alter or diminish the determination of Victor Vickers' eligibility for the asserted credit.
