**NARRATIVE STATEMENT:**

**I. GENERAL:**

This engineering statement and the instant engineering exhibit of which it is part has been prepared on behalf of ACTION COMMUNITY TELEVISION BROADCASTING NETWORK, INC., (hereinafter "ACTBN").

ACTBN is the licensee of digital Class-A Television Station WHIG-CD, Rocky Mount, North Carolina, FCC facility identification number 168101, and is authorized to operate on digital television Channel 31.

**DISPLACEMENT APPLICATION**

By means of the instant application, ACTBN seeks authorization to change its authorized television channel from digital Television Channel 31 to digital Television Channel 30.


ACTBN's authorized operation on channel 31 has been displaced, as it is within 265 kilometers of three (3) UHF co-channel full-service digital television facilities. (See the Table below and Figure 1).

In accordance with 47 CFR §73.3572 (a)(4)(ii) "Processing Of TV Broadcast, Class A TV Broadcast, Low Power TV, TV Translators, And TV Booster Applications." A UHF Low Power TV station that is located within 265 kilometers of a co-channel full service digital station allotment point or license is qualified for displacement relief and priority processing.

Therefore, it is qualified for displacement and priority processing in accordance with the §73.3572 (a)(4)(ii) of the Commission's rules.
