For the reasons provided in the application request, Special Temporary Authority IS GRANTED for operation of the station above with the parameters specified in the STA request only. The licensee is responsible for addressing any complaints of interference that may arise.

Specific parameters authorized:
Latitude: 47 degrees 12’ 31”, Longitude: 122 degrees 25’ 50” (NAD83, to nearest second).
Transmitter site is on the grounds of Westminster Presbyterian Church, 5236 E B St., Tacoma, WA
Effective radiated power: 0.003 kW (three watts) directional, main antenna lobe pointed toward 30 degrees True.
Other parameters as specified in the STA request, as supplemented on February 8, 2021
No other site or ERP is authorized.

When operations pursuant to this STA commence, the licensee shall file a Notice of Resumption of Operations in the FCC’s CDBS electronic filing system.

We remind the licensee that the station's license will expire as a matter of law upon twelve consecutive months of silence [**ending September 30, 2021**], notwithstanding the grant of the present STA. See Pub. Law No. 104-104, 110 Stat. 56, Section 403(1) (1996) and Order, *Silent Station Authorizations*, FCC 96-218 (released May 17, 1996). See also Public Notice, *Expedited Processing of Applications Filed by Silent Stations*, DA 96-818 (May 22, 1996). Please be aware that unauthorized operations – operations with facilities not authorized by a current STA or license – do not count as a resumption of operations within one year for the purposes of Section 312(g) of the Communications Act, and cannot be used to avoid the consequences of Section 312(g). See *A-O Broadcasting Corporation*, FCC 08-10, 23 FCC Rcd 603 (2008).

This STA authority expires **August 17, 2021**.

Considerations:
