

### Changes in Interests as a Result of Assignment

CMCG Puerto Rico License LLC (the assignor licensee entity) is a wholly-owned subsidiary of CMCG Puerto Rico LLC (the assignee entity), which, in turn, is a wholly-owned subsidiary of Corporate Media Consultants Group II LLC. Max Media IV LLC holds 100% of the voting units of Corporate Media Consultants Group II LLC.

The Form 316 application requests FCC authority to assign CMCG Puerto Rico License LLC into its parent, CMCG Puerto Rico LLC. No other significant changes in beneficial ownership are proposed.

After deducting nonattributable ownership interests and applying the multiplier, the individuals who vote through indirect interests in the licensee *before* and *after* the assignment will be:
