Initial Broadcasting of California, LLC (“IBC”) is a “manager-managed” limited liability company under the Delaware Limited Liability Company Act. Peter L. White is the Manager of IBC, and in such capacity manages IBC’s business, subject to the terms of the Limited Liability Company Agreement of IBC. Certain actions to be taken by IBC require the approval of IBC’s Board of Representatives, which consists of three members: Peter L. White, Nicholas B. White, and Kevin T. Lilly, each of whom has one vote; provided, however, that the Limited Liability Company Agreement of IBC restricts Mr. Lilly’s involvement in the affairs of IBC to the extent necessary to insulate Mr. Lilly from holding a cognizable interest in IBC under the Commission’s Rules, and prohibits Mr. Lilly, in his capacity as a Member of IBC or a member of the Board of Representatives, from voting on, and requires Mr. Lilly to recuse himself from any consideration of, any matter with respect to which his involvement would be inconsistent with his insulated status. Because Mr. Lilly is precluded from involvement in the media affairs of IBC, the other two members of the Board of Representatives, Peter L. White and Nicholas B. White, are shown on this application as each holding 50% of the voting power in IBC by virtue of their respective seats on the Board of Representatives.
