

**EXHIBIT 11**  
**PARTIES TO APPLICATION AND OTHER BROADCAST INTERESTS**

Pegasus Satellite Communications, Inc. (“PSCI”) wholly owned by Pegasus Communications Corporation (“PCC”). PSCI and PCC are both Delaware corporations.

PCC is a public company. Class A Common Stock representing approximately 33% of the voting rights of PCC is held by public shareholders.<sup>1</sup> PCC’s direct parent company is Pegasus Communications Holdings, Inc. (“PCHI”), which is a Delaware holding company. Either directly or through wholly owned corporations, PCHI holds Class B Common Stock representing approximately 48% of the voting rights in PCC.<sup>2</sup> Pegasus Capital Holdings LLC, a Delaware limited liability company, holds the remainder of PCC’s Class B Common Stock, representing approximately 18% of the voting rights of PCC. Pegasus Capital Holdings LLC is controlled by Marshall W. Pagon, an individual.

The voting stock of PCHI is held by Pegasus Communications Limited Partnership (“PCLP”), a Connecticut limited partnership. PCLP is controlled by its sole general partner Northwest Management Associates, L.P. (“NMALP”), a Pennsylvania limited partnership.

NMALP has a single general partner, Pegasus Cable Associates, Ltd., a Pennsylvania corporation, which is wholly owned by Marshall W. Pagon. Because Mr. Pagon has actual control, the interests of the limited partners of PCLP and NMALP are not reported here.<sup>3</sup>

Through his control of PCHI and Pegasus Capital Holdings LLC, Marshall W. Pagon holds approximately 66% of the voting interests of PCC.

<sup>1</sup> Some officers and directors may hold Class A stock. Among these are Marshall W. Pagon, whose interests are already attributable. To the extent that other individuals hold such stock, all hold less than 5% of the voting interest in PCC.

<sup>2</sup> Pegasus Northwest Offer Corp., a Delaware corporation, holds Class B Common Stock representing 2% of the voting rights of PCC. Pegasus Scranton Offer Corp., a Delaware corporation, also holds 2% of the voting rights of PCC. PCHI owns 100% of the stock of each of these companies.

<sup>3</sup> Among the limited partners of PCLP and NMALP are other limited partnerships in which certain officers, directors and employees of the operating companies hold equity interests. As noted above, Marshall W. Pagon controls the general partner of both entities. Because he exercises actual control over these entities, he is deemed to hold 100% interest in both PCLP and NMALP.

In the interest of complete disclosure, it is noted that the mother of Marshall Pagon, the Chief Executive Officer and controlling shareholder of PCC, is married to W.W. Keen Butcher, the Chief Executive Officer and Chairman of the Board of Managers of KB Prime Media LLC (“KB Prime”), licensee of WSWB(TV), Scranton, Pennsylvania, and the permittee of WTLF(DT), Tallahassee, Florida and New DTV Channel 42, Hammond, Louisiana. KB Prime is an applicant for new NTSC full power television stations in Gainesville, Florida (Ch. 61); Jackson, Mississippi (Ch. 51); Wiggins, Mississippi (Ch. 46) and Tupelo, Mississippi (Ch. 35). PCC and its related entities hold an option to acquire any or all of the membership interest and/or assets of KB Prime. PCC and its related entities have provided neither equity nor debt financing to KB Prime, although it has provided credit support for third-party debt financing. This arrangement has been approved by the Commission on two occasions. See FCC File Nos. BAPCT-981116IA and BALCT-980526IA.
