The instant engineering STA is necessitated in order to allow WMVX(AM) to continue operation at a site which is the subject of an FCC Form 301 application, BP-20151119AYB. In support, the following should be noted:

(A) The pending modification application appeared on FCC Public Notice on November 30, 2015, Report No. 28621. See Attachment A.

(B) It was published in the Federal Register on December 8, 2015. See Federal Register, Vol. 80, No. 235 (Attachment B). Thus, the application, assuming no oppositions, could be granted anytime after February 8, 2016.¹

(C) Attached is a June 24, 2015 letter from Endicott College to Costa advising that the current tower lease for WMVX(AM) would not be renewed. Pursuant to the letter, Costa was told it had to cease broadcasting effective January 1, 2016 (Attachment C).

Costa, since receipt of the letter, has diligently attempted to find a site to relocate WMVX(AM). After much effort, Costa was able to secure space at the site which is the subject of the pending modification application.

Endicott College has given Costa a slight reprieve from the January 1, 2016 date. It has advised Costa that it can remain at the site until February 1, 2016. Thus, the term of the instant STA would be brief. In this regard, it would only be for the relatively short period of time until the Commission disposed of the pending application. It would permit the station to continue broadcasting and advance the Commission's often stated mandate to facilitate the provision of

radio service. See Section 307(b) of the Communications Act of 1934, as amended. Clearly, this mandate overrides the reality of the cessation of broadcast service.² Moreover, the STA would only be for a relatively brief period of time.

² WMVX(AM) currently broadcasts Portuguese language programming. It would be a hardship to the WMVX listeners if this programming were no longer available. Thus, continuation of service without interruption would clearly be in the public interest.

Albany Engineering Corporation; Notice of Successive Preliminary Permit Application Accepted for Filing and Soliciting Comments, Motions To Intervene, and Competing Applications

On September 22, 2015, Albany Engineering Corporation filed an application for a successive preliminary permit, pursuant to section 4(f) of the Federal Power Act (FPA), proposing to study the feasibility of hydropower at the New York State Canal Corporation's Lock C1 Dam located on the Hudson River in Saratoga and Rensselaer Counties, New York. The sole purpose of a preliminary permit, if issued, is to grant the permit holder priority to file a license application during the permit term. A preliminary permit does not authorize the permit holder to perform any land-disturbing activities or otherwise enter upon lands or waters owned by others without the owners' express permission.

The proposed Waterford Hydroelectric Project would consist of the following: (1) An existing 672-foot-

long and 15-foot-high ogee-shaped concrete gravity dam with a 356-foot-long tainter-gated structure forming the eastern portion of the dam; (2) an existing impoundment having a surface area of 400 acres and a storage capacity of 5,000 acre-feet at the spillway crest elevation of 28.3 feet National Geodetic Vertical Datum; (3) either a new powerhouse at the east end of the dam with two identical turbine generator units with a total installed capacity of 10.2 megawatts (MW) (Scenario 1), or two new identical modular floating barge-type structures at the west end of the tainter gates housing 18 turbine-generator units with a total installed capacity of 4.0 MW (Scenario 2); (4) a proposed 10,000-foot-long, 34.5-kilovolt transmission line; and (5) appurtenant facilities. The proposed project would have an annual generation of 39,000 megawatt-hours (MWh) (Scenario 1) or 12,000 MWh (Scenario 2).

This proposed information collection in the Second Further Notice of Proposed Rulemaking, FCC 98-147, will be used by the Commission, state commissions, and competitive carriers to facilitate the deployment of advanced services and other telecommunications services in implementation of section 251(c)(6) of the Communications Act of 1934, as amended. 
Pursuant to the terms of the Lease between Willow Farms (WNSH) and Endicott College dated February 24, 2006, which was assigned to Costa-Eagle Radio Ventures Limited Partnership effective March 31, 2011 (the "Lease"), and in follow up to the letter sent to you by Lynne O'Toole, Vice President Of Finance, on April 9, 2104, this is to confirm that Endicott College will not renew the Lease upon its expiration . As we have discussed, the transmitter must be powered down on or before January 1, 2016.

Pursuant to Section 19 of the Lease, "Removal of Lessee's Property," Costa-Eagle Media will have sixty (60) days from the date of expiration of the Lease to remove its property from the leased premises and it shall be required to properly repair any and all damage cause by such removal.

As you know, the College has made good faith efforts to work with Costa-Eagle Media to eliminate the problems caused by the interference from its radio transmission. At this point, the College has made its final determination that it is simply not in the College's interest to continue the Lease.
