Dear YPBC staff:

This is in reference to the request filed on September 23, 2016. YPBC requests an extension of the STA granted on April 1, 2016, to operate during nighttime hours with parameters at variance due to severe damage to tower #3 (top part snapped off in storm).<sup>1</sup> In support of the request, YPBC states that it now plans to replace tower #3, which must be followed by the required filing of an FCC Form 302 application (to update all operating parameters and obtain a new license).

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for extension of STA IS HEREBY GRANTED, and YPBC may continue to operate the station at night with DA parameters at variance from licensed values and/or reduced power while maintaining monitor points within licensed limits, with no change to the licensed daytime operation (or ND at night with a maximum of 0.25 kW when replacing tower #3). It will be necessary to further reduce power or cease operation if complaints of interference are

received. YPBC must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. See 47 CFR § 1.1310. We anticipate that YPBC will be able to file the required FCC Form 302 application before the expiration date shown below in order to show that substantial progress has been made.

This authority expires on **April 28, 2017**.
