ARTICLES OF INCORPORATION
OF
THOMAS-DALE DEVELOPMENT COUNCIL

We, the undersigned Incorporators, of full age, for the purpose of forming a corporation under and pursuant to the Provisions of Chapter 317, Minnesota Statutes, known as the Minnesota Non-Profit Corporation Act, and the laws amendatory thereof and supplementary thereto, do hereby constitute ourselves as a body corporate and hereby adopt the following Articles of Incorporation:

I

The name of this corporation shall be Thomas-Dale Development Council.

II

The purposes of this corporation shall be:

1. To restore, conserve and foster a neighborhood residential, commercial and industrial environment conducive to urban living for all segments of the population by virtue of its convenience, amenities, safety, services, visual attractiveness and economic stability.

2. To restore, conserve, and enhance, where feasible and desirable, the identity of existing sub-neighborhoods in the Thomas-Dale area by rehabilitating to the extent possible the existing structures in the area and by strengthening those elements which serve to give identity to an area, such as population composition, neighborhood gathering places, educational and recreational facilities, and similar factors tending to characterize and/or give identity to each sub-neighborhood.

3. To restore, conserve, and foster neighborhood design and environment in which each land-use can function efficiently and without adversely affecting or being adversely affected by adjacent land users; where new construction is physically and visually compatible in design and scale with the then existing neighborhood and where the normal educational, recreational, spiritual, shopping service, jobs and other needs of the residents may be provided within the neighborhood.

4. To remove blight and conditions of deterioration by:

- a. Undertaking an extensive program of voluntary rehabilitation.
- b. Undertaking a program of public rehabilitation of deteriorated buildings in order to demonstrate rehabilitation feasibility.
- c. Undertaking a program of acquisition and demolition of buildings blighted to the extent of being incapable of being rehabilitated, substandard buildings, or buildings otherwise determined to represent blighting influences.

5. To encourage the provision of new housing of varying types appealing to and meeting the needs and economic constraints of all segments of the Thomas-Dale population; to stage the provision of such housing, where feasible, so as to maximize its utilization by residents of the area who will be displaced by public action; and to assure that the special housing needs of the elderly are met.

6. To encourage and foster home ownership, particularly for families of low and moderate incomes, and younger families capable of contributing to the social and economic vitality of the city and the Thomas-Dale community.

7. To secure the development, redevelopment, or expansion of public and semi-public facilities contributing to the residential attractiveness or safety of the neighborhood, including parks, playgrounds, schools, churches, facilities for philanthropic organizations, community centers, utilities and sewers, libraries, and similar facilities.

8. To achieve better vehicular and pedestrian circulation patterns in the neighborhood through:

- a. The redesign and reconstruction of major streets where appropriate.
- b. The evaluation, redesign, and reconstruction of the internal residential street system in order to eliminate or reduce unnecessary through traffic or other factors detrimental to the residential environment.
- c. Securing the development of off-street parking areas for residential, commercial, industrial and other uses which tend to be traffic generators.
- d. The reconstruction or construction of sidewalks, pedestrian-ways, street lights, traffic control devices, and other facilities contributing to pedestrian comfort and safety.

9. To foster economic stability of resident-serving commercial and industrial facilities in the neighborhood by acquiring and removing blighted and economically obsolete commercial and industrial facilities; making sites available for new commercial and industrial construction; and by encouraging the grouping of commercial and industrial facilities at appropriate locations in the neighborhood where such facilities can be mutually supporting and provide greater convenience and service to residents.

10. To encourage new private investment by members of the community by making sites available for new housing, commercial and industrial construction.

11. To encourage to the fullest extent the continuing participation of the members of the community as represented through the Project Area Committee working with the Housing and Redevelopment Authority and other groups, agencies and departments in the continuing planning, programing, and implementing activities under the NDP program.

12. To do all things reasonably necessary to carry out and implement the above, all without limitation on any of the foregoing objectives or purposes, the corporation shall have all of the powers set forth in Minnesota Statutes annotated in Section 317.16.

III

This corporation shall not provide pecuniary gain directly, indirectly, or incidentally to any of its members.

IV

The duration of this corporation shall be perpetual.

Contributions made to you are deductible by donors in computing their taxable income in the manner and to the extent provided in Section 170 of the Internal Revenue Code.


