Subject to the provisions of the Communications Act of 1934, as amended, treaties, and Commission Rules, and further subject to the conditions set forth in this permit, authority is hereby granted to construct an FM broadcast station located and described as follows:

This permit shall be automatically forfeited if the station is not ready for operation within the time specified or within further time as the Commission may allow unless completion of the station is prevented by causes not under the control of the permittee.
