

Description of Transaction

This application seeks Commission approval for the transfer of control of The University of Memphis, the license of WUMR, from the present board of trustees to an entirely new board of trustees. Because the proposed transfer will result in a 100% voting change in the board of trustees for WUMR, use of FCC Form 315 is appropriate.

Changes in Interest in as a Result of Transfer

The current board of trustees for WUMR is comprised entirely of members of the Tennessee Board of Regents (“TBR”).¹ In 2016 the State of Tennessee passed legislation authorizing a state university board for each TBR university.²

Below is a list of the present and proposed trustees for The University of Memphis. Because the proposed change is done by state law, there is no written agreement memorializing the proposed changes.

¹ The TBR system consists of 46 educational institutions of higher learning, including six state universities, 13 community colleges, and 27 colleges. The State of Tennessee created TBR in 1972 for setting policies and guidelines for all educational institutions in the TBR system.
