ENGINEERING STATEMENT
KROX (AM) AND KYCX-FM OWNERSHIP STUDY
MJ COMMUNICATIONS, INC./SIMMONS-AUSTIN, LS, LLC

This Firm has been retained by MJ Communications, Inc. Licensee of radio stations KROX (AM), 1590 kilohertz and KYCX-FM, 104.9 megahertz, Mexia, Texas and Simmons-Austin, LS, LLC, proposed assignee of the Mexia, Texas radio stations to prepare this Engineering Statement regarding the Mexia, Texas radio market.

The presently licensed KROX (AM) and KYCX-FM facilities are both licensed to Mexia, Texas, an unrated market in rural north Texas. Simmons-Austin LS, LLC owns stations KQRL, 1580 kilohertz, KRZI, 1660 kHz and KLRK, 92.9 mHz in the Waco, Texas market.

The presently licensed facilities overlap all or part of the city grade contours of the following stations:

* Subject Stations

The market contains six stations under the definitions contained in Section 73.3555(a)(iv) permit a single owner in a market of fourteen or fewer stations to own or control a maximum of 5 commercial radio stations with no more than three in one service. MJ Communications, Inc. complies with this requirement. Exhibit E1-1 is a map on which are plotted the 5.0 mV/m contours of all pertinent AM stations and the 3.16 mV/m contours of all pertinent FM stations. The AM station contours are plotted in green; the FM station contours are plotted in blue.

MJ Communications, Inc. is filing an application to relocate the KYCX-FM transmitter site to a new location west of Mexia and increase the effective radiated power of the station. The city grade coverage of the proposed operation overlaps the contours of two additional FM stations licensed to Waco, Texas. These are WACO-FM, 99.5 mHz and KWTX-FM, 97.5 mHz. This brings the total number of stations to eight. The map of Exhibit E1-1 shows the proposed 3.16 mV/m contour of station KYCX-FM in red. This application has no effect on the station ownership compliance issue.

The map of Exhibit E1-2 shows the Simmons Media interests in the Waco, Texas market, the closest market in which Simmons has stations, along with the licensed and proposed contours

of stations KRQX (AM) and KYCX-FM. None of the licensed or proposed city grade contours overlap any of the Simmons Media city grade contours. Thus the present and proposed Mexia stations are in full compliance with section 73.3555 of the Rules.

All distances to contours were calculated and plotted in exact accordance with the Rules of the Commission.
